RESOLUTION NO. 1814.06

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AUTHORIZING AND APPROVING THE ATTACHED MUTUAL AID AGREEMENT AND JOINT DECLARATIONS BETWEEN THE TOWN OF GOLDEN BEACH AND THE CITY OF NORTH MIAMI BEACH; AUTHORIZING THE TOWN MAYOR TO EXECUTE THE **AGREEMENT** DECLARATIONS AND AUTHORIZING THE POLICE CHIEF TO EXECUTE DECLARATIONS; AUTHORIZING **IMPLEMENTATION** THE AGREEMENT **OF** DECLARATIONS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, there exists a continuing possibility of public safety concerns including law enforcement problems and other natural and manmade conditions which are, or are likely to be, beyond the control of the services, personnel, equipment or facilities of the Town of Golden Beach Police Department and the City of North Miami Beach Police Department; and

WHEREAS, pursuant to the Florida Mutual Aid Act, Chapter 23, Florida Statutes, municipalities have authority to enter into mutual aid agreements to permit voluntary cooperation and assistance of a routine law enforcement nature across jurisdictional lines; and

WHEREAS, the Town of Golden Beach (the "Town") and the City of North Miami Beach (the "City") desire to enter into a Mutual Aid Agreement and Joint Declarations for these purposes; and

WHEREAS, the Town Council finds that approval of the Mutual Aid Agreement and Joint Declarations between the Town and the City is in the best interest of the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. Recitals Adopted. That each of the recitals stated above is hereby adopted and confirmed.

Section 2. Agreement and Joint Declarations Approved. That the Mutual Aid Agreement and Joint Declarations, in substantially the form attached hereto, are hereby approved.

Section 3. Execution Authorized. The Town Mayor is hereby authorized to execute said Agreement and Joint Declarations on behalf of the Town, and the Police Chief is hereby authorized to execute said Joint Declarations on behalf of the Town, once approved as to form and legal sufficiency by the Town Attorney.

Section 4. Implementation. That the Town Mayor and Town Manager are hereby authorized to take any and all action necessary to implement the terms and conditions of the attached Agreement and Joint Declarations.

Section 5. Effective Date. That this Resolution shall take effect immediately upon adoption hereof.
