

#### Letter FROM THE MAYOR



want to wish all of our residents a happy and healthy New Year! I hope everyone enjoyed the holidays and are looking forward to 2018 which I know will be a fabulous and prosperous year in Golden Beach. We have many projects and events planned for 2018.

**Some current project updates:** We are progressing on our Beach Pavilion. Until the project is completed, there will be limited use of the Pavilion, but our residents and their guests will still have access to the beach. There are temporary bathrooms available to utilize while construction is in progress. Once the Beach Pavilion is completed, the residents will see a major improvement to our Beach amenities.

Work on the Guardhouse/Police Substation is progressing nicely which will provide extra security to the Town. I'd like to remind our residents that there may be occasional traffic back-ups during peak hours while entering and exiting at The Strand. Please be patient and considerate while the project is going on.

The street lighting project is underway. We have signed the contract with Florida Power & Light and are ordering the lights. An additional 80 plus lights will be added to the Town's current system, which will add more safety to the residents and at the same time, beautify our Town. All of these projects are expected to be completed in 2018.

We hope our residents plan to participate in our very first Doggie Day on the Beach. Due to years of requests by so many of our residents, we the Council, decided to give it a try are hopeful it will be a success.

Town resident safety and security are a major concern of our staff and Council. We are investigating additional measures to keep our Town safe and improve the security of the Town.

Hurricane season has ended, however Hurricane Irma had a major impact on the Town. The time to prepare is now. If you are interested, now would be the time to investigate acquiring a generator. Please be advised that existing TECO Gas customers who would like to install generators or add a gas-powered appliance must confirm meter capacity size by applying for a permit. For more information please contact the Town's Building & Zoning Department.

If you have not already, please be sure that you complete and return the Resident Survey. It is very important that you submit this information to us. It will help us provide the kinds of services that our residents want. We have a lot of projects in the works, and we are very excited for 2018.




































# Doggie Day ON THE BEACH

is already well underway. I hope everyone has had a healthy and prosperous start to the new year.

In 2017 the Golden Beach Police Department accomplished many goals and planned activities, such as: the Florida DMV event, Back to School event, Career Day at OJUS Elementary School, Red Ribbon Week, Boating Safety Training class with the Coast Guard, National Night Out, and Movie Night.



Reflecting on the past year, as we strive to serve you better, I would like to thank Mayor Singer, the Town Council members and the Town Manager for their constant support in making the Golden Beach Police Department a Class 1 Law Enforcement Agency.

After Hurricane Irma, officers from the Golden Beach Police Department sat for a Sergeant Promotional Examination. Promotions will be held as soon as we receive the approval of

the Town Manager and Mayor Singer. These promotions will enhance the operation of the Police Department as we continue to set goals to improve the department.

On the December 14, 2017, the Golden Beach Police Department hosted a Movie Night at South Park where close to 40 residents attended to watch the movie "MOANA". We will continue doing Movie Night as a yearly entertainment event for all our residents. On December 18, 2017, I was invited by the 3rd District Court of Appeals to participate in the promotional ceremony of police officers assigned to the courthouse.

The Golden Beach Police Department is not only very proactive inside the Town but also beyond our borders, as we assist adjacent police departments, schools and non-profit organizations.

Our Department has (3) three detectives assigned to investigate in-depth crime-related activities with the Internal Revenue

Service, South Florida Money Laundering Task Force and Drug Enforcement Agency. These investigations could lead to the prosecution of individuals arrested for offenses against our Country, or of any State, County, Municipality or any territory of the United States. If any assets are seized for forfeiture, such as money, vehicles, land, real property, businesses, etc., the lead agencies participating in the investigation could benefit from the sale and/or distribution of equitable shared funds. The Assets Forfeiture Program is used as a tool by many law enforcement agencies to enhance law enforcement goals, objectives and operations.

The Golden Beach Police Department has long established efforts to foster open communication with our residents. We have tried to accomplish this through community events, and other collaborative efforts in order to partner with our residents. This partnership is a two way street of communication where we as the police department work closely together with the community strengthening and improving the relationship that exists. Community engagement is critical to every law enforcement agency, as it helps close any gap in communication. Therefore, we as the law enforcement agency serving Golden Beach, are concerned with some observed behavior that we need to address. There are areas of concern that we've noticed while patrolling the streets of Golden Beach. Many of our officers are reporting seeing these security concerns on a regular basis. Concerns such as the front door to a dwelling wide open, a car left with the windows down and the car keys inside the car, garage doors left completely open for easy access, bicycles left unsecured on driveways, etc.

We have also noticed that residents are going out of town and are not notifying us nor are they setting their burglar alarms. While you're on vacation an officer could routinely go by your residence to make sure it is secured. This can be done by calling the administration officer at (305) 936-2444 and requesting a "Watch Order".

Should you be out of Town and your home or property be burglarized, we ask that notify the Golden Beach Police Department immediately. We have noticed that in many instances this has not been done. By keeping us informed you allow us help us serve the community as a whole and prevent crimes before they occur.



One of our major concerns is the monitoring of beach goers and beach access to non-residents. This has been a topic that has been debated for years, and officers were enforcing mandates without a policy. So to ease the officers concern(s) and to satisfy the residents demands, I drafted the below policy so we could all have some guidance to follow.

#### **POLICY:**

It is the policy of the Golden Beach Police Department to safeguard the welfare of our residents and their property. Hence, the beach patrol is the responsibility of all department members on duty and was initiated in order for police officers to watch the beach residences along the beachside in Golden Beach. The Golden Beach Ocean and/or beach perimeter area is for the exclusive use of land owners and their visitors. Therefore based on the platted surveys and maps such area is to be considered private, and not a recreational beach area. All residents of Golden Beach can use the beach designated area at the Beach Pavilion.


#### **PROCEDURES:**

- While on routine patrol, an officer will advise any person on the beach who hasn't been invited by a homeowner, that the beach is not a recreational beach but private property.
- 2. He/she must advise visitors to traverse to Hallandale Beach or Sunny Isles Beach by giving them directions.
- 3. If visitor refuses to move/ traverse, he/she must be advised of the consequences for refusing to leave the immediate area, which includes; a "Trespassing after Warning" arrest, at which time a supervisor will be requested to respond to the scene. Additionally, the lot owner will also be contacted and advised of the situation and asked if they want the person(s) evicted from their lot, and/or arrested for trespassing. The Homeowner will need to be advised that he will need to prosecute by filling out a prosecution form. Also the homeowner will be informed that his/her information will be included in the arrest form for subpoena purposes. The visitor will once again be advised to leave the immediate area, or will be arrested for trespassing after warning on private property.
- 4. A homeowner can call police for trespassers on neighboring properties, but cannot demand an arrest if the trespasser is not on their property.
- 5. The wet and compact sandy area below the "mean highwater line" is considered a public area and is to be utilized by visitors to traverse to Hallandale Beach and/or Sunny Isles Beach. Officers can't demand anyone on the water to leave as the water is owned by the state.

In closing, I would like to thank you for your support. We look forward to continuing to serve our residents and their families in the coming years.


#### SOME EXCITING THINGS ARE BREWING AROUND TOWN.

#### HERE'S A QUICK BREAKDOWN OF SOME THINGS TO EXPECT:



#### STREET LIGHTING

The Town's eagerly anticipated street lighting contract has just been signed with conversion expected to be underway by the third quarter of 2018. The project involves a complete overhaul and replacement of the Town's existing street lighting with more modern, energy efficient and attractive fixtures.















#### BEACH PAVILION AND STRAND GATEHOUSE RENOVATIONS

It's hard to miss that renovations are well underway at both the Strand Gatehouse entrance of Town and the Beach Pavilion. Pardon our dust while we wrap these projects up; estimated time for delivery is April 2018.





#### **CANAL MAINTENANCE**

In order to make our intracoastal waterways more navigable and to remove excess silt deposits the Town will undergo canal maintenance. The Town has entered the permitting phase for the canal dredging project; more details on when the process will begin will be released when they are made available.

#### RESIDENT SURVEYS


We are excited to see the overwhelming response from our Residents in regards to the 2017 Residents Survey. We have gotten some amazing feedback, insights and



#### **ASKED TO UPDATE 'NO TRESPASSING' STATUS**

In an effort to ensure residents' safety and the safeguarding of their property the Golden Beach Police Department has initiated a high visibility detail on the beach area.

The purpose behind this detail is three-fold; first to keep visitors walking on the beach informed of our rules and laws concerning the properties along the beach side of Town; second as a deterrent to possible crimes; and third and most important, to build community trust and confidence in our Police Department.

To assist us with our goals, we are asking ocean-side residents to update their Trespass Affidavit by calling the Golden Beach Police Department, Monday through Friday, 9am to 5pm, at (305) 936-2444, to have a copy of this important form delivered to their home. This form must be completed by the owner of the property and authorizes the Golden Beach Police Department (as the property owner's representative) to enforce all applicable State and Municipal Trespass laws.

This procedure will authorize the Golden Beach Police Department to detain, cross-examine, arrest and prosecute any violator/trespasser.

#### Walking Season Returns:

#### FOOT TRAFFIC INCREASES

As our thoughts turn to that New Year's resolution of finally getting back in shape combined with mild South Florida weather, it's no surprise people are motivated to get out and hit the streets. Winter and early spring are opportune times for those who enjoy walking, whether you live in Town or a short sprint away. You may see an influx of walkers using our streets and sidewalks and wonder who they are and if they could possibly all live here in Golden Beach; there's a very good chance that some of them don't. While unfamiliar faces may cause concern, that doesn't mean it's time to panic or haul them off for trespassing.

It's important to realize that the Town's streets are public roads, so any public citizen has the right to drive on them (or strap on their sneaks and go for a stroll on them). The Town is aware that we may have non-residents in Town, but rest assured that the Police Department is being extra vigilant in its patrolling to be sure fitness enthusiasts are not a potential problem for those who live here. Some residents have mentioned that the pedestrian gates in Town are not locked during the day and have inquired if those gates are malfunctioning. Please be aware that only certain pedestrian gates have the capability to lock (the North and South Gate entrances, for example) while others act as a visual deterrent but not a barricade; access is not completely restricted because those gates provide entry to public thoroughfares. Just like The Strand Gatehouse, where vehicles may be stopped but are never denied access (unless there is an outstanding safety or logistical issue to the vehicle entering); our pedestrian gates serve as a way to discourage an open flow of foot traffic into the Town but do not prohibit it in its entirety. However, please note that the Police Department will now padlock all pedestrian gates in Town from 10PM to 6AM. Residents will not be given keys to these padlocks; anyone wishing to enter or leave the Town during those hours will need to do so through The Strand.

The Town also requests any Residents who find gates malfunctioning or see potential areas of access (holes in hedges, fencing, etc.) please contact Town Hall at (305) 932-0744, and for afterhours concerns please contact The Strand Gatehouse at (305)935-0940. Please remember if you notice any suspicious activity please contact the Golden Beach Police Department immediately at (305)935-0940, for emergencies call 911.

# Don't Find Yourself in the Doghouse: PICK UP AFTER YOUR PET

A bouquet of flowers, a platter of fresh baked cookies, or even finally returning that weed-whacker you borrowed last summer: These are all nice surprises you can give to your neighbor. There is another surprise that has been spotted around town that has neighbors steaming. This "gift" is usually left behind by one of the four-legged members of the family and can ruin anyone's stride across the lawn to pick up the morning paper. Let's just say being a good neighbor includes picking up after yourself, especially if Fido leaves something behind on your walk. It's not just a courtesy, it's also the law. Aside from being stinky and altogether unpleasant, pet waste transmits disease. That can be disease spread from animal to animal, or even animal to human.

The Town has a zero tolerance policy on pet owners or pet handlers who do not clean up after their pets. Pet owners/handlers who do not clean up after their pets are committing a criminal misdemeanor which is prosecutable by the State Attorney's Office. This means, residents, their staff and/or guests who walk their pets on public or private property and do not pick up the pet's waste will be cited without warning or exception. Non-compliant pet owners/handlers are subject to a \$150.00 fine without warning for each offense. Residents, please inform your staff, that the State of Florida has enacted a mandatory hold policy on undocumented

individuals; a seemingly small infraction could have major consequences. Please be aware that the Town is using surveillance, including undercover Police Officers, to identify offending pet owners/handlers and will act immediately on anyone who is not in compliance. Pet waste bag stations and trash cans are available throughout Town for your convenience. PLEASE NOTE THAT THE TOWN'S PUBLIC WORKS DEPARTMENT IS NOT RESPONSIBLE FOR PICKING UP PET WASTE.

So whether you're taking your animal for a spin around town or playing in the Town's dog park, be mindful and please make sure not to leave any "surprises" for those who come after. Avoid citations, be a responsible pet owner and clean up after your animals. Help us keep Golden Beach clean!



# When a single phone number isn't enough... He needs an ID powered by PetHub

#### Golden Beach has a High Tech WAY TO REGISTER YOUR PET

We live in a "there's an app for that" world. With your cellphone you can chat with friends, review your finances, and even order Chinese food from the place down the street, all with the swipe of a finger. There's no doubt apps have made our lives more "user-friendly." Joining this trend, the Town has partnered with an app to help keep you and your pets connected. While Fido and Mittens don't have smartphones of their own, there's no reason technology can't help make their lives easier too. With the "Get Me Home" app managed by Pethub, residents will have a way to find their furry family members if they get lost or wander away from home. Each ID tag has a "QR (Quick Response) Code," which is scannable by any smartphone. Residents will be able to create an Online Pet Profile complete with owner information and critical pet data. An image and stats of the pet, its license number and any health information are all pulled up simply by scanning the QR code. In the event their pet gets lost, residents will be able to reach a staffed Pethub call center 24/7; Pethub reports that 96% of pets are returned home in less than 24 hours. The Town of Golden Beach and Pethub want to keep you and your pets where they belong, within snuggling distance. 
