# Letter FROM THE MAYOR



**he Town of Golden Beach has always been proactive regarding the environment.** So whether we agree or disagree with the recent decision of the President to withdraw from the Paris Climate

Accord, we will continue to address environmental issues pertinent to Golden Beach. We believe in the reality of rising tides which is why we have invested in a new storm water drain system. We also encourage the use of LED and solar energy. We stand strong in being environmentally friendly and putting the environment first. We encourage preservation, protection, or restoration of the natural environment and natural ecosystems.

Hurricane season has arrived. We have been fortunate over the last several years in avoiding direct impact from a major storm. Please be proactive rather than reactive. Secure your homes and check for leaks now. It is best to make sure that you have disaster kits and emergency supplies prior to hurricane season which should include flashlights, batteries, garbage bags and more. Also, make sure you secure your boats and watercraft to prevent damage or loss.

With the rainy season upon us, there is a renewed concern about the Zika virus and other mosquito-borne illnesses. The Town has increased its treatment options from last year to ensure that we are aggressively addressing any and all possible issues. Clarke Environmental Mosquito Management has been contracted to provide bi-annual treatments of all of our catch basins, weekly treatments of our Beach Pavilion and Town Parks, and weekly community-wide spraying from May to October.

The funding that the Town Manager and I had sought during our trip to Tallahassee has been finalized. The Town has survived a government veto and has received \$100,000.00 for our street lighting project. We are also going forward with renovations to the Police Substation/Guardhouse and the Beach Pavilion.

I hope everyone has an enjoyable summer. If you are traveling and will be away from your homes for any significant length of time, make sure that you secure your homes before you leave. In addition, stop by Town Hall to submit a House Check form so that the Police Department can conduct extra checks of your property to reinforce security.

If you have any questions, do not hesitate to contact Town Hall. The Town Manager and his staff are always available to assist you.

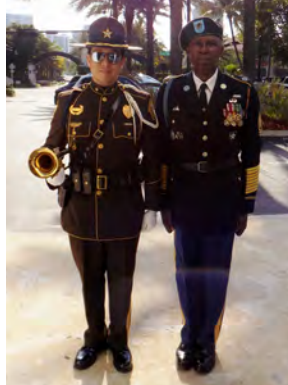

# Police BEAT

**We have entered the 2017 hurricane season, and with such unpredictable weather, the best way to be prepared is to be informed.** The Town of Golden Beach Police Department encourages all residents to register with the CodeRED emergency alert system. The system keeps subscribed residents informed of evacuation notices, missing children alerts, boil water notices, flood disasters, fire or police emergencies, severe weather alerts, etc. Notification can be received via cell phone, land line, text message or email. To enroll simply visit the Town's website [www.goldenbeach.us](http://www.goldenbeach.us) and click on the CodeRED link under the Resident's tab.



**Back in January 2017, K-9 Officer Julio Soca was shot twice while conducting an area search for an armed suspect in Miami Shores.** This incident became an eye opener for many police officers county-wide and reminded us how precious life is. Officer Soca received the necessary assistance from the

Town of Golden Beach and I'm happy to announce that Officer Soca is back to work patrolling the streets of Golden Beach with his K-9 "Tyson".

**As we continue our Law Enforcement journey, the Police Staff and I realize that training and community policing are two of the many essential parts of our jobs.** That's why the staff and I are always energetic in developing new training(s) not only for our police officers, but also for our residents and other police departments. Some of the training(s) that we have put together are:

- "The Boating Safety Course" conducted for residents at Town Hall
- The mandatory "O.C. (oleoresin capsicum) Spray Refresher Training Class" for our GBPD Officers, and
- "The Officer Involved Shooting and Critical Incident Course" in which a total of fourteen Police Agencies and close to 80 Officers participated.

Other informal meetings that I attended were the yearly “Miami-Dade County Hurricane Preparedness Seminar” and the “Island Chiefs Meeting” focusing on Law Enforcement Advisory from the League of Cities.

**Autism, or autism spectrum disorder, refers to a range of conditions characterized by challenges with social skills, repetitive behaviors, speech and nonverbal communication, as well as unique strengths and differences. Officer Lopez recognized an aspiring officer there giving him a few goodies from the Golden Beach Police Department, including a picture frame and a replica badge. I spoke with this young man personally and he is very eager to become a police officer as a way to help his community and other kids with autism.

# *Town addresses* **FERAL CATS**



**Feral cats are an essential part of beach communities as they are natural hunters whose mere presence serves to control populations of rodents and other vermin. If feral cats' natural inclination to hunt for their food is altered by human intervention through feeding they can become a nuisance. Feral cats' numbers can skyrocket along with numbers of the pests they would typically prey upon if they were still hunting instead of being fed. It is wise not to approach feral cats; their lack of domestication can make them aggressive and unpredictable especially if they feel cornered or threatened.**

The Town's feral cat initiative involves humanely trapping, treating, neutering and returning the cats, as long as they are healthy. This initiative will help to create a cat population that is appropriate for a community our size. We are looking for homeowners who have noticed feral cats congregating on their properties and who would be willing to have live traps set up around the outside of their homes. Please be aware that the treated animals are returned to the area they were collected; Florida State Law prohibits relocating animals from their native habitat under its cruelty to animals legislation (Florida State Statute 828.12 and 828.13). Anyone convicted of animal cruelty is subject to fines of up to \$5,000 and/or up to 5 years in prison.

**If you are interested in having live traps set up around the outside of your home please contact Michael Glidden at Town Hall ([mglidden@goldenbeach.us](mailto:mglidden@goldenbeach.us)) to have your home added to the list of approved feeding/trapping sites.** These sites must be registered with the Town in order to prevent code citations for unauthorized feeding from being issued. Setting up feeding areas outside of your own property (i.e. in vacant lots, neighbors' yards, right-of-ways, Town parks, etc) is strictly prohibited. Please be aware that the Golden Beach Code Enforcement Department will fine anyone caught feeding feral cats \$250.00 without issuing a warning; if you are feeding cats on your property as a registered site of the Town's trap/neuter/release program you WILL NOT be cited for a code violation for unauthorized feeding.

**The Town is sensitive to the concerns of residents that these animals be treated in a humane manner and we assure you that the intention is to help all of the animals that are healthy and not to euthanize unless completely necessary.** The Town is also open to suggestions and recommendations as we look to humanely control the Town's cat population. We ask for your cooperation during this process.

## *Town of* GOLDEN BEACH GARBAGE & TRASH COLLECTION

Updated June 2017

Use this Sheet as a Reminder – Post Near Your Waste Receptacles for Easy Reference

Due to environmental concerns, State and County Laws, and increased cost of solid waste disposal, the Town Council adopted an ordinance establishing standards for garbage and trash collection and a fee schedule for bulk items which cannot be practically boxed, bagged, or bundled. We appreciate your cooperation in helping us keep our Town clean by complying with the following code requirements:

### **COLLECTION DAYS**

**Hours: 8 am - 4 pm**

**Garbage Collection:** Monday\* and Thursday

**Trash Collection:** Tuesday and Friday\*\*

**Recyclable Material Collection:** Wednesday

\*If Monday is a holiday, garbage collection is on a Tuesday.

\*\*No trash should be put out after 2PM on Fridays or on weekends or holidays.

### **HOW DO I DISPOSE OF ITEMS?**

**GARBAGE:** “Garbage” refers to regular household waste. These items should be placed in the blue receptacle imprinted with the Golden Beach logo. Do not place garbage in the containers furnished for recycling. **ALL GARBAGE MUST BE PLACED IN PLASTIC BAGS.** Garbage bins may be left alongside of homes. Access gates must be unlocked or gate code must be supplied to Town in order for bins to be retrieved, once bins are emptied the Town’s Public Works Department will return bins to where they were found. If you do not wish to leave gates open or to give access information to the Town you may leave your bins curbside for collection **NO EARLIER** than 6PM the night before

pickup and you must return your bins to their proper storage area **NO LATER** than 6PM the day of collection.

**TRASH:** “Trash” refers to larger items, including discarded furniture and other oversized articles. All trash must be placed curbside for collection.

**RECYCLABLE MATERIALS:** **ALL RECYCLABLES ARE TO BE PLACED IN THE DARK BLUE CONTAINER IMPRINTED WITH THE WSI LOGO.** Do not confuse it with the blue garbage receptacle imprinted with the Golden





Beach logo. Please place your newspapers, aluminum cans, tin cans, glass bottles, jars and plastic bottles LOOSELY in this recycled waste container. DO NOT PUT RECYCLABLES IN BAGS. No telephone books, cardboard or plastic bags.

**SEPARATE YOUR TREE TRIMMINGS AND PLANT WASTE** - They may not be commingled with garbage. Do not place tree trimmings and plant waste on top or near drains.

Tree limbs, plant waste, branches, or hedge clipping, shall not exceed 3' in length, shall be properly tied and secured in bundles not weighing more than 40 lbs. and placed curbside for collection. Items that may not be easily bagged, boxed or tied will not be picked up unless arrangements for special collection with the Public Works Department have been made. Landscapers are responsible for hauling away the garden trash they generate.

### **BULK TRASH**

All items which may not be picked up with the normal collection will be picked up after arrangements have been made with the Public Works Department. Call Town Hall at 305.932.0744 Ext. 235 to make arrangements for a special pick-up.

### **BULK TRASH FEES**

Light load:

Minimum Charge

(2 cubic yards or less) \$30.00

(2-4 cubic yards) \$60.00

For unusually heavy loads, the cost of dumping may be added to the minimum charge. Loads exceeding 5 cubic yards will be charged \$7.00 per cubic yard plus the cost of dumping. Pre-paid check only.

### **CONSTRUCTION WASTE**

Any trash or rubbish generated as a result of construction activity is the responsibility of the homeowner and their contractor(s). For more information on required permitting for construction waste and dumpsters please contact the Town's Building & Zoning Department at 305-932-0744.

### **ILLEGAL DISPOSAL**

It shall be unlawful to deposit garbage, plant wastes, garden trash, rubbish and other materials on any vacant lots, or Town property, streets, storm drains, canals, and beach areas, and to deposit, sweep or blow grass onto Town streets or pile trash over storm drains. If you see an individual dumping on a vacant lot, or any other illegal dumping, call the Police Department immediately.

It is also unlawful to randomly dispose of used motor oil, paint, batteries, gas tanks, and other combustible or potentially hazardous material. Public Works WILL NOT pick up this kind of waste. Miami-Dade County has a facility located at 140 NW 160th Street that will accept these items for disposal. This center is open daily from 7 am to 5:30 pm. You can find additional information on the Miami-Dade DERM website at [www.miamidade.gov/derm](http://www.miamidade.gov/derm).

If at any time items cannot be picked up during regular garbage/trash runs, a Public Works employee may leave an orange-colored door hanger to notify you of any violations. Please follow the directives outlined on the hanger.

## *Landscape Irrigation* RESTRICTIONS

Miami-Dade County

### **Existing Landscaping:**

- Watering is NOT allowed between 10 AM and 4PM
- Residents with ODD numbered addresses may water lawns and landscaping on Wednesdays and Saturdays from 12AM to 10AM and/or 4PM to 11:59PM
- Residents with EVEN numbered addresses may water lawns and landscaping on Thursdays and Sundays from 12AM to 10AM and/or 4PM to 11:59PM

### **New Landscaping/Sod:**

- Water regulations for New Landscaping and Sod fluctuate depending on age and specifics of Landscaping. Please consult South Florida Water Management District website for full details at [www.sfwmd.gov](http://www.sfwmd.gov)

### **Avoid Code Citations:**

Did you know?

Grass over 6" is a violation of Town Code with a \$150 fine for the first offense (multiple offenses result in increased penalties). Keep your lawn maintained to help keep Golden Beach looking its best while avoiding costly code citations.

**June 1 starts Florida's tropical storm season. It's time to think about preparing for and responding to storm events and other emergencies on the beach seaward of the coastal construction control line (CCCL).**

Florida Department of Environmental Protection CCCL staff responsible for emergency permitting of coastal construction in your community stand ready to assist property owners, agents, government officials, wildlife biologists and other environmental professionals with property, projects or emergency management responsibilities seaward of the Coastal Construction Control Line. In addition, keep an eye on our website's Hurricane Information page to learn more about the Department's hurricane response activities.

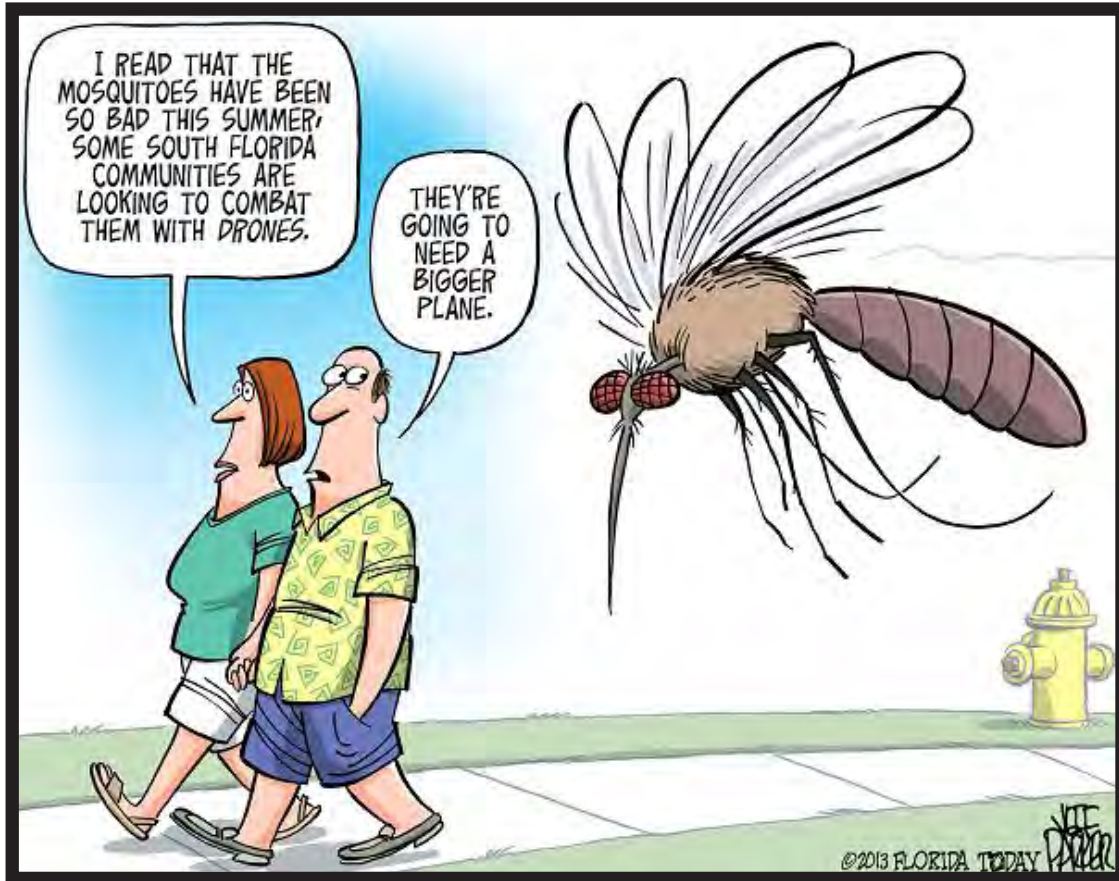

## Mosquito SPRAYING

**Clarke Environmental Mosquito Management has been contracted to provide mosquito management services to the Town of Golden Beach. They will actively address any mosquito-related issues in the Town from May through October 2017.** This will include community-wide truck ULV treatments, barrier treatments for our parks and beach/pavilion, and treatments of our catch basins, inlets, and manholes.

Truck ULV treatments (fogging/spraying) will take place weekly on Wednesday mornings from 5:00 – 6:00 A.M. Following this, Clarke will then conduct the barrier treatments. All treatments shall be completed and Clarke employees will have left Town no later than 9:00 A.M.

Town Hall also has bottles of OFF mosquito repellant spray; residents wishing to collect a bottle may stop by Town Hall.

# Mosquitoes and Construction Sites

Disease-spreading mosquitoes can breed in nearly any container that holds water. This can include items around a construction site, such as water-filled jersey barriers, concrete floors, construction dumpsters, drums, five-gallon buckets, plastic litter, empty cans and bottles, plumbing and duct banks, elevator vaults and the like.

If you manage a construction site, here's how you can reduce mosquitoes at your site:

## **WATER-FILLED CONSTRUCTION BARRIERS**

Water-filled construction barriers can breed mosquitoes. Even when empty, rainwater can enter through cracks or an open drain plug. Here's how to keep them from breeding mosquitoes:

- Treat them with a commercially available mosquito larvicide that contains Bti (*Bacillus thuringiensis israelensis*), methoprene, or larviciding oil.
- Cover and seal barriers properly, replace damaged barriers.

## **CONSTRUCTION DUMPSTER**

Mosquitoes take about one week to go from egg to adult. Have your construction dumpster emptied at least once per week to break up the mosquito life cycle. Additionally, treat dumpsters with a commercially available larvicide (see above).

## **FIVE-GALLON BUCKETS, PLUMBING AND DUCT BANKS, AND OTHER SMALL CONTAINERS**

Here's how to keep these items from breeding mosquitoes:

- Remove any unnecessary containers such as buckets; for containers you do need, either turn them upside down or store them where they can't fill up with rainwater.
- Discard or eliminate old bathtubs, sinks, toilets, or other plumbing fixtures. If you need to keep them onsite, cover them or store them where they can't fill up with rainwater.
- Keep building materials and supplies off the ground and positioned in such a way as to avoid creating areas of standing water and areas that are inaccessible for treatment.
- Seal duct banks and keep shower, spa, and pool areas free of water.

## **CANS, BOTTLES AND OTHER FOOD AND BEVERAGE CONTAINERS**

Provide workers with a container or bag for proper disposal of cans, bottles and food or beverage containers when they're done.

Mosquitoes can lay eggs in an item as small as a bottle cap from a water or soda bottle.

- Keep work areas in workmanlike order.
- Treat elevator vaults with a commercially available larvicide (see above).

## **PROTECT YOUR WORKERS FROM MOSQUITO BITES**

Make sure workers wear long sleeves, long pants and socks, and put on mosquito repellent.

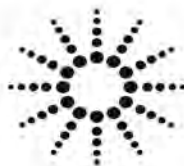

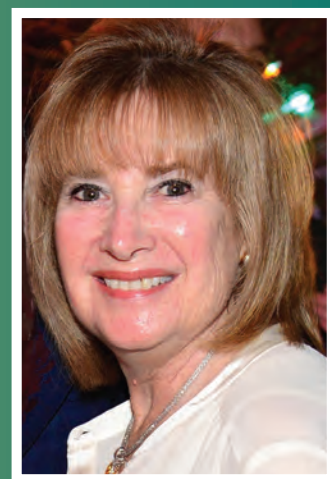
