




Police BEAT

t's hard to believe spring is almost here, which will give our residents an excellent opportunity to enjoy the beauty of Golden Beach and all of its amenities.

I'd like to start off by saying that I am extremely proud of the men and women of the Golden Beach Police Department. The Town of Golden Beach continues to be one of the safest communities in South Florida. This is in part because of the hard work of our law enforcement officers.



Our Police Department is consistently working to develop strategies that will keep the Town and adjacent communities safe. On Saturday, January 4, 2017, the Town's K-9 Officer, Julio Soca, responded to a call from the Police Department in Miami Shores. Officer Soca responded to assist with locating an armed masked subject. As units from other jurisdictions were taking perimeter positions around the affected area, our K-9 unit started searching for the subject. As

Officer Soca and his K-9 "Tyson" made entry into an abandoned house located at NE 11 Ct. and 106 Street, the subject who was hiding inside started firing his weapon, hitting Officer Soca twice. Officer Soca was subsequently taken to Aventura Hospital where he was treated and eventually released. On Thursday, February 23, 2017, during the Miami-Dade County Police Chiefs Association award ceremony, Officer Soca received a plaque for his bravery and dedication to duty. We are grateful to him for his commitment to service and we are happy to report that he is in good spirits.

As we continue our proactive approach to communityoriented policing and outreach, our department joined Mayor Glenn Singer at the Samuel Scheck Hillel Community School. Mayor Singer and police staff members interacted with the students and spoke about the function of different governmental positions, including the Mayor and Police Chief. The students were very involved and knowledgeable, actively participating and asking questions. Afterwards, the students were treated to a presentation by Officer Willie Lopez

with "McGruff the Crime Dog" on how to safely avoid strangers. On Saturday, February 18, 2017, Police Staff attended the Diabetes Research Institute Foundation Gala at the Diplomat Hotel. The Golden Beach Police Department is committed to keeping you safe year round, in a manner that is both proactive and innovative. DANGER?

Home improvements can be risky business that can put homeowners in serious danger. If you have performed construction, are currently performing construction, or are thinking of performing construction in Town, you may not think to ask yourself "Am I putting myself in danger?" Even so, the answer may be "Yes."

That is, of course, unless you've taken one simple precaution. Have you pulled a permit with the Town? If you have, then you can breathe a sigh of relief.

While pulling permits can be seen as "inconvenient," "intrusive" or just "downright expensive," these important documents are a critical part of the construction process. Permit fees aren't a shifty way for the Town to tap extra money from its residents, in actuality they protect residents far more than most may realize.

When contractors apply for construction permits, the Building and Zoning Department works diligently to assure the contractor has all the appropriate credentials to conduct business within Town, including Workers Compensation Insurance (WCI). WCI protects homeowners should anything go wrong while their home is under construction. Unscrupulous contractors may shirk insurance to save themselves a few dollars. However, a fall from the roof, a life threatening injury, or any accident on the job could leave an employee unable to work and looking to collect damages. If the employer of the injured worker does not have insurance the employee will collect from whomever he or she can, often suing homeowners for allowing an uninsured contractor to perform work on their home. In the wake of an accident, homeowners can be left to cover crippling hospital bills and lawsuits. The results can be devastating.

Don't lose your home to a costly lawsuit brought on by an ill-prepared contractor. Saving a little money by not applying for permits could cost you everything.

Your Building Department is putting your interest and safety above all else.

Will this Require a PERMIT?

If you've contemplated a home improvement project, or any home related project, you've probably caught yourself asking this exact question: "Will the work I'm doing require a permit?" Permits and the subsequent inspection processes are important to protecting homeowners, relieving them from liability, and insuring any and all labor is up to hurricane codes as well as building codes. The Town of Golden Beach adheres to the Florida Building Code. Therefore, a building permit is required for all new construction and for any repairs or reconstruction which alter a structure. Building permits are also required for other construction projects, including driveways, fences, exterior painting, landscaping/tree removal and pools.

On your right is a list of projects that would require a permit. This list is supplied as an example and may not include every type of project. Please note that some projects may require approval from the Building Regulatory Advisory Board (BRAB). Before starting any construction project be sure to contact Town Hall. The Building & Zoning Department will gladly set you up with all materials necessary to make your project run as smoothly as possible. You may submit building permit applications to the Town's Building Department located in Town Hall at 1 Golden Beach Drive, Golden Beach, FL 33160. If you have any questions you may also reach us by phone at (305) 932-0744.

Section 105.1 of the Florida Building Code states:

Any owner or authorized agent who intends to construct, enlarge, alter, repair, move, demolish, or change the occupancy of a building or structure, or to erect, install, enlarge, alter, repair, remove, convert or replace any electrical, gas, mechanical or plumbing system, the installation of which is regulated by this code, or to cause any such work to be done, shall first make application to the building official and obtain the required permit.



We've all had it happen. You're sitting at home comfortably, safe from the heat of Florida's seemingly eternal summers, and all the sudden the air starts to turn. It gets warm, stuffy, and within moments someone exclaims "Is it hot in here or is it just me?"

Don't panic, there are many licensed air conditioning repair companies in South Florida, but be sure to follow Emergency Permitting Procedures with the Town, in order to save yourself from costly violations.

Work performed within Town requires proper work permits, whether it be new construction or repairs. We know losing your air conditioning can be an aggravating and uncomfortable experience. Just remember to follow these simple requirements to make sure no one gets hot under the collar:

When you need to make an emergency A/C repair:

- 1. Call the Town Building & Permitting Department and explain your situation at (305) 932-0744 x237.
- 2. The Building Department will contact the Chief Mechanical Inspector and request permission for the repairs to be granted.
- 3. If the Chief Mechanical Inspector approves the work, residents have 24 hours to submit a permit to perform the job.
- 4. Any work performed without the proper permitting in hand leaves the owner exposed to possible code violations for work without permits, resulting in fines.

Be sure to follow proper avenues while performing repairs on your home and Stay Cool!






