RESOLUTION NO. 1011.97

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH FLORIDA, APPROVING A MUTUAL AID AGREEMENT WITH THE CITY OF NORTH MIAMI BEACH, FLORIDA, FOR LAW ENFORCEMENT SERVICES; AUTHORIZING THE APPROPRIATE TOWN OFFICIALS TO EXECUTE THE AGREEMENT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the continuing possibility exists that public safety concerns could cause the Chiefs of Police of North Miami Beach or Golden Beach to seek additional resources for law enforcement purposes on a short term basis.

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AS FOLLOWS:

Section 1. That the Mutual Aid Agreement between the Town and North Miami Beach dated January 21, 1997 is hereby approved.

Section 2. That in circumstances where said agreement and the State Wide Mutual Aid Agreement for Catastrophic Disaster Response and Recovery, dated April 24, 1994 and modified October 21, 1994 (to which the Town is a party) is also implemented, then the State Wide Agreement shall take precedence over this agreement with North Miami Beach.

Section 3. The Mayor and other Town officials are authorized and directed to execute this agreement.

Section 4. Severability. Should any provisions of this Resolution be declared by a court of competent jurisdiction to be invalid, the same shall not affect the

validity of the Resolution as a whole, or any part thereof, other than the part declared to be invalid.


Section 5. Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 6. Effective Date. That this Resolution shall become effective upon approval of the Town Council.


