

**GOLDEN BEACH, FLORIDA  
RESOLUTION NO. 1019.97**

**A RESOLUTION OF THE TOWN OF GOLDEN BEACH, FLORIDA; ASSIGNING EACH COUNCILMEMBER THE DUTY TO INQUIRE INTO THE OPERATION OF A PARTICULAR AREA OF GOVERNMENTAL RESPONSIBILITY FOR A PERIOD OF SIX MONTHS IN ORDER THAT THE COUNCILMEMBER SHALL BECOME INFORMED AS TO THE OBJECTIVES OF THE GOVERNMENT OF GOLDEN BEACH; AND PROVIDING AN EFFECTIVE DATE.**

**BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA:**

**Section 1.** That pursuant to Section 3.05 of the Town Charter the Councilmembers listed below are hereby assigned the duty to inquire into the operation of a particular area of governmental responsibility relating to the Town of Golden Beach in order to become informed as to the objectives of the Town Government. This assignment shall remain in affect until September 16, 1997 (regular Council meeting) unless amended by resolution or motion of the Town Council.

**Section 2.** That the various areas of Town Government are Parks and Recreation, Beautification, Law and Finance, Police, and Public Works and are hereby assigned as follows:

<u>Councilmember</u>	<u>Government Responsibilities</u>
Mayor Cuenca	<u>Law / Finance</u>
Vice Mayor Chikovsky	<u>Police</u>
Councilmember Addicott	<u>Beautification</u>
Councilmember Fistel	<u>Parks &amp; Recreation</u>
Councilmember Lowrance	<u>Public Works</u>

**Section 3.** This assignment shall be effective until Tuesday, September 16, 1997, unless extended by motion or resolution of the Town Council.

**Section 4. Effective Date.** That this Resolution shall become effective upon approval of the Town Council.

The Motion to adopt the foregoing Resolution on first reading was offered by Vice Mayor Sara Chikovsky, seconded by COUNCIL MEMBER Lisa Lowrance, and on roll call the following vote ensued:


