RESOLUTION NO. 1026.97 OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA; CERTIFYING THE RESULTS OF THE FEBRUARY 18, 1997 TOWN ELECTION FOR MAYOR AND TWO TOWN COUNCIL MEMBERS; DESIGNATING THE VICE MAYOR; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to law, and properly noticed, a municipal election was held on February 18, 1997 in the Town of Golden Beach; and

WHEREAS, the Town Council desires to accept the certification of the results of the election and designate a Vice Mayor pursuant to the Town Charter;

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA:

Section 1. That the Certification of the results of the February 18, 1997 Town election are accepted as follows:

- Section 2. A. That based upon the results, Judy Cuenca is declared Mayor for a two year term commencing immediately.
- B. That based upon the results, having received the two highest numbers of votes cast, Sari Addicott and Sara Chikovsky, are declared Town Council members for four year terms commencing immediately.

Section 3. That Sara Chikovsky, having received the highest number of votes cast, is hereby designated Vice Mayor for a one year term commencing immediately, to be followed by Sari Addicott as Vice Mayor for the succeeding one year term.

Section 4. That a copy of the certified results is attached to this resolution as Exhibit 1 and is incorporated herein.

Section 5. Severability. Should any provisions of this Resolution be declared by a court of competent jurisdiction to be invalid, the same shall not affect the validity of the

Resolution as a whole, or any part thereof, other than the part declared to be invalid.


Section 6. Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 7. That this Resolution shall become effective immediately upon its adoption.


