RESOLUTION NO. 1048.97

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA; APPOINTING ROBERT "SKIP" JOHNSTON INTERIM TOWN MANAGER; PROVIDING FOR SALARY AND BENEFITS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Robert "Skip" Johnston was appointed Town Finance Director and Acting Town Manager by the Mayor, pursuant to the Town Charter, on May 23, 1997; and

WHEREAS, the Mayor has nominated Mr. Johnston to the position of Interim Town Manager, pursuant to the Town Charter.

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AS FOLLOWS:

<u>Section 1.</u> That Robert "Skip" Johnston is hereby appointed Interim Town Manager, to serve at the pleasure of the Town Council. He is granted all the authority, powers and duties of the Town Manager as provided in the Town Charter, Ordinances, Resolutions and other applicable law.

Section 2. That Mr. Johnston shall receive compensation as follows:

- (a) Salary at the annual rate of \$60,778.00
- (b) Reimbursable car allowance up to \$600.00 per month for lease or purchase payment, insurance, maintenance and fuel.
- (c) The same vacation and sick leave accruals as other administrative Town Employees.
- (d) Such other benefits, if any, as determined by Resolution of the Town Council.

Section 3. Severability. Should any provisions of this Resolution be declared by a court of competent jurisdiction to be invalid, the same shall not affect the validity of the Resolution as a whole, or any part thereof, other than the part declared to be invalid.

<u>Section 4.</u> Conflict. That all resolutions or parts of resolutions in conflict with this resolution are hereby repealed to the extent of such conflict.

<u>Section 5.</u> <u>Effective Date.</u> That this Resolution shall become effective upon approval of the Town Council.
