RESOLUTION NO. 1049.97

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN BEACH, GOLDEN FLORIDA ADOPTING TENTATIVE MILLAGE RATE OF THE TOWN OF GOLDEN FOR THE **FISCAL** YEAR COMMENCING OCTOBER 1, 1997 AND ENDING SEPTEMBER 30, 1998 PURSUANT TO SECTION 200.065, FLORIDA STATUTE (TRIM BILL); SETTING DATE, TIME AND PLACE FOR PUBLIC HEARING TO ADOPT FINAL MILLAGE RATE FOR THE TOWN OF GOLDEN BEACH; AUTHORIZING THE TOWN CLERK TO ADVERTISE PUBLIC HEARING; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town has properly noticed the first public hearing scheduled for Wednesday, September 3, 1997 at 7:30 p.m. in the Council Chambers of the Town Hall located at One Golden Beach Drive, Golden Beach, Florida; and

WHEREAS, the said first public hearing was held as noticed and the public and all interested parties having had an opportunity to address their comments to the Town Council and having complied with the "TRIM" requirements of the Florida Statutes;

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> That the tentative millage as presented by the Mayor and the Town Manager for the fiscal year commencing October 1, 1997 and ending September 30, 1998 be and is hereby fixed at the rate of 8.7377 mills which is \$8.7377 per one thousand dollars of assessed property value within the Town of Golden Beach.

Section 2. That the "rolled back rate" for the Town of Golden Beach is 8.4430 mills and that the tentative millage rate of 8.7377 is 3.490% above the "rolled back rate."

That the Second public hearing required by Section 200.065 of the Florida Statutes to adopt a final millage rate for the fiscal year commencing October 1, 1997 and ending September 30, 1998 be and is hereby set in the Town Council Chamber, One Golden Beach Drive, Golden Beach, Florida at 7:30 p.m. on Tuesday, September 9, 1997.
- Section 4. That the Town Clerk is hereby authorized and directed to advertise the said public hearing as required by law.
- <u>Section 5.</u> <u>Effective Date.</u> That this Resolution shall become effective immediately upon approval of the Town Council.
