## **RESOLUTION NO. 1060.97**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA; APPOINTING TOWN MANAGER ROBERT "SKIP" JOHNSTON INTERIM TOWN CLERK; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Town Clerk Patricia Mongiello is moving away from Town and resigned effective October 1, 1997; and

WHEREAS, the Town Charter, at Sec. 3.04(d), provides that the Town Council shall appoint a Town Clerk; and

WHEREAS, the Town Charter, at Sec. 3.04(e), provides that the Town Council shall permit the Town Manager to serve as Town Clerk, in addition to his regular duties as Town Manager; and

WHEREAS, the Town Council desires to appoint Town Manager Robert "Skip" Johnston as Interim Town Clerk;

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That Town Manager Robert "Skip" Johnston is hereby appointed Interim Town Clerk, to serve at the pleasure of the Town Council while serving as Town Manager. He is granted all the authority, powers and duties of the Town Clerk as provided in the Town Charter, Ordinances, Resolutions and other applicable law.

<u>Section 2.</u> That Mr. Johnston shall receive no compensation in addition to his compensation as Town Manager for serving as Interim Town Clerk.

<u>Section 3.</u> Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

<u>Section 4. Effective Date.</u> That this Resolution shall become effective immediately upon approval of the Town Council.
