<u>Section 1.</u> That the Town Council hereby accepts the resignation of Councilwoman Lisa Lowrance effective retroactively to December 19, 1997 as stated in the resignation.

<u>Section 2.</u> That the Town Council expresses its appreciation to Councilwoman Lisa Lowrance for her diligent service to the Town as an elected official.
