

**GOLDEN BEACH, FLORIDA**

**RESOLUTION NO. 1070.97**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA REGARDING THE PROPOSED SCHOOL BOUNDARIES FOR THE HIGH SCHOOL SS "DDD" AS SUBMITTED BY THE NORTH MIAMI BEACH FEEDER PATTERN ABC COMMITTEE; ENDORSING AND URGING THE ADOPTION OF THE COMMITTEE'S RECOMMENDATION; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the North Miami Beach Feeder Pattern ABC Committee, comprised of representatives from 12 targeted communities, (hereinafter referred to as the "NMB Committee") has met on several occasions since November 1997 and has held community meetings receiving and considering public comments regarding school boundaries; and

**WHEREAS**, after considering several alternatives, the NMB Committee has unanimously agreed on a proposed school boundary plan; and

**WHEREAS**, the accepted proposal incorporates the existing boundaries of Highland Oaks Middle School to become the boundaries of the new SS "DDD" High School; and

**WHEREAS**, the accepted proposal incorporates the existing boundaries of JFK Middle School to remain the existing boundaries for North Miami Beach High School; and

**WHEREAS**, the accepted proposal further provides for elementary school to be configured as grades K-5; and middle school to be configured as grades 6, 7 and 8; and high school to be configured as grades 9, 10, 11 and 12; and

**WHEREAS**, the Town Council of the Town of Golden Beach at its January 7, 1998 Special Council Meeting received a report from Councilwoman Sari Addicott, who is Co-Chair of the NMB Committee and the Town Council had an opportunity to discuss the proposals;

**NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:**

**Section 1.** That the above preambles are correct.


**Section 2.** That the ABC District Committee is urged to adopt the NMB Committee recommendation as referenced above, in this Resolution.

**Section 6. Effective Date.** That this Resolution shall become effective immediately upon approval of the Town Council.
