**RESOLUTION NO. 1079.98**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA ACKNOWLEDGING THE RESIGNATION OF POLICE CHIEF RICHARD WITT; THANKING HIM FOR HIS PUBLIC SERVICE; AND PROVIDING AN EFFECTIVE DATE

**WHEREAS**, Chief Richard Witt was appointed as Golden Beach Police Chief on July 1, 1996 and has served since that time; and

**WHEREAS**, Chief Richard Witt has submitted a resignation dated February 11, 1998, effective March 6, 1998, which has been accepted by the Town Manager;

**NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:**

**Section 1.** That the Town Council hereby recognizes the resignation of Chief Richard Witt and his retirement from law enforcement having served as Police Colonel for the City of Miami and Chief of Police for the City of Hollywood, prior to his appointment to Golden Beach Police Chief.

**Section 2.** That the Town Council expresses its appreciation to Chief Richard Witt for his diligent service to the Town while serving as Police Chief, bringing to the Town his vast experience in law enforcement, acting in a leadership capacity for the Town and the Department, and acting as a mentor for the officers under his command.


**Section 3.** That the Town extends to Chief Witt its best wishes for a long and healthy retirement.


**Section 4. Effective Date.** That this Resolution shall become effective immediately upon approval of the Town Council.
