

**GOLDEN BEACH, FLORIDA  
RESOLUTION NO. 1081.98**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, APPROVING THE PAYMENT OF THE PREMIUM FOR A DISABILITY INSURANCE POLICY FOR TOWN MANAGER ROBERT "SKIP" JOHNSTON; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, Robert "Skip" Johnston was appointed Town Manager pursuant to Resolution No. 1048.97, adopted June 17, 1997, as amended by Resolution No. 1057.97; and

**WHEREAS**, the Town Council desires to include a disability insurance policy as an employment benefit of the Town Manager;

**NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:**

**Section 1.** That Robert "Skip" Johnston is hereby granted reimbursement of the premium paid, or direct by the Town, payment for a disability insurance policy in an amount not to exceed \$353.00 per month, payable annually, semi-annually, or monthly, with benefits payable to Mr. Johnston.

**Section 2.** That in all other respects Resolution Nos. 1048.97 and 1057.97 are hereby ratified as to the salary and benefits for the Town Manager.

**Section 3. Severability.** That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of


this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

**Section 3. Effective Date.** That this Resolution shall become effective immediately, upon approval of the Town Council.
