GOLDEN BEACH, FLORIDA RESOLUTION NO. 1098.98

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA; APPOINTING POLICE CHIEF HERNAN CARDENO TO SERVE AS INTERIM TOWN MANAGER; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Town Manager Robert "Skip" Johnston has submitted a resignation dated May 8, 1998, effective May 22, 1998; and

WHEREAS, the Mayor has nominated Police Chief Hernan Cardeno to serve as Interim Town Manager until a replacement Town Manager is nominated by the Mayor and appointed by the Town Council;

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> That Police Chief Hernan Cardeno, having been nominated by Mayor Judy Cuenca, pursuant to the Town Charter, is hereby appointed Interim Town Manager, effective May 22, 1998 at the close of business, when Mr. Johnston's resignation takes effect.

<u>Section 2.</u> That as Interim Town Manager, Chief Cardeno shall continue with his authority as Town Police Chief and also have all of the authority of Town Manager as provided by the Town Charter, Ordinances and Resolutions, as well as the laws of the State of Florida and any other applicable regulations.

Section 3. That Police Chief Hernan Cardeno shall receive a 15% salary increase over his present Police Chief salary during the time of his service as Interim Town Manager.

<u>Section 4.</u> Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

<u>Section 5. Conflict</u>. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 6. Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.
