RESOLUTION NO. 1101.98

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, PURSUANT TO CHAPTER 22-79 (PARK FEES) SETTING THE AMOUNT OF THE FEES ESTABLISHED BY THE TOWN CODE FOR USE OF TWEDDLE PARK BY NON-RESIDENTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING AN EFFECTIVE DATE.

BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That pursuant to Town Code Sec. 22-79, "Park Fees," the rate of the following fees is hereby established:

- A. Non-resident use of Tweddle Park
 - 1. Daily Charge = \$5.00 per Adult, \$3.00 per Child
 - 2. Weekly Charge = \$25.00 per Adult, \$10.00 per Child
 - 3. Monthly Charge = \$75.00 per Adult, \$45.00 per Child
- B. Additional parking fee for Non-residents paying to use Tweddle Park shall be at metered parking at the rate of \$1.25 per hour.

<u>Section 2.</u> Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

<u>Section 3.</u> Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 4. Effective Date. That this Resolution shall become effective July 1, 1998.
