A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA; APPOINTING CAROLE S. MORRIS AS TOWN MANAGER; PROVIDING FOR SALARY AND BENEFITS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Pursuant to Town Charter, Mayor Judy Cuenca has nominated Carole S. Morris to the position of Town Manager and urges this appointment by the Town Council;

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> That Carole S. Morris is hereby appointed Town Manager, effective Monday, July 6, 1998, to serve at the pleasure of the Town Council. She is granted all the authority, powers and duties of the Town Manager as provided in the Town Charter, Ordinances, Resolutions and other applicable law.

## Section 2. That Ms. Morris shall receive compensation as follows:

- (a) Salary at the annual rate of \$75,000.00, with the same pay periods as other administrative Town Employees;
- (b) Severance pay in the amount of one month's base salary for each month worked up to a maximum of six months salary for termination without cause;
- (c) Reimbursable car allowance up to \$600.00 per month for motor vehicle.

  lease or purchase payment, insurance, maintenance and fuel;
- (d) Professional Development seminar expenses and professional memberships as budgeted by the Town Council;

- (e) Deferred Compensation payable at the annual rate of 10% of the annual Town Manager salary, up to the legal maximum amount, in lieu of joining the Town pension plan, deposited pro rata in monthly, or more frequent, periodic installments to a deferred compensation account (such as ICMA) that is available to Town Employees;
- (f) The same health insurance coverage as other administrative Town Employees
- (g) A disability insurance premium reimbursement in the amount to be determined by motion of the Council;
- (h) Immediate accrual of forty hours annual leave after the first day on the job.

<u>Section 3.</u> Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

Section 4. Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

<u>Section 5.</u> Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.
