## **RESOLUTION NO. 1113.98**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA; APPOINTING A MEMBER TO THE BUILDING REGULATION ADVISORY BOARD; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, a vacancy has occurred on the Building Regulation Advisory Board due to the resignation of one of its members; and

WHEREAS, the Town Council desires to appoint a Board member to fill the vacancy, pursuant to the Town Charter, Sec. 2-76;

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That Doris Cohen is hereby determined to be legally qualified to serve on the Building Regulation Advisory Board, being a resident of the Town of Golden Beach and having resided in the Town for two years preceding this appointment.

<u>Section 2.</u> That Doris Cohen is hereby appointed by the Town Council to serve on the Building Regulation Advisory Board at the pleasure of the Town Council for the unexpired portion of a three year term, expiring April 1, 2001.

<u>Section 3.</u> Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

Section 4. Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

<u>Section 5.</u> Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.
