A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA; DESIGNATING THE PERMIT FEE FOR PERSONAL PROPERTY SALES AS ESTABLISHED BY TOWN CODE SECTION 15-33 (ADOPTED BY ORDINANCE NO. 434.98); PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town Council adopted Ordinance No. 434.98 authorizing and regulating personal property sales; and

WHEREAS, that ordinance provided for a permit fee to be established by resolution;

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

- **Section 1.** That the permit fee for personal property sales as created by Section 15-33 of the Town Code is hereby established at \$50.00.
- <u>Section 2.</u> That this fee amount shall remain in effect unless and until it is amended or repealed by resolution or ordinance of the Town Council.
- <u>Section 3.</u> Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.
- Section 4. Conflict. That all resolutions or parts of resolutions in conflict with this

 Resolution are hereby repealed to the extent of such conflict.
