RESOLUTION NO. 1118.98

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA; APPROVING THE CONCEPT OF A TRI-CITY LIBRARY OPERATED BY EQUITABLE CONTRIBUTIONS FROM THE MUNICIPALITIES OF GOLDEN BEACH, SUNNY ISLES BEACH AND AVENTURA: URGING THE MIAMI-DADE COUNTY BOARD OF COUNTY COMMISSIONERS TO RELEASE THESE THREE CITIES FROM THE COUNTY LIBRARY SYSTEM: **PROVIDING** FOR SEVERABILITY: PROVIDING FOR CONFLICTS; AND PROVIDING AN EFFECTIVE DATE.

BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> That the Town Council agrees in concept with the proposal for a Tri-City Public Library supported by Sunny Isles Beach, Aventura and Golden Beach, with each of the three municipalities providing financial support for the operation of such a library based upon an equitable formula to be agreed among the three municipalities.

Section 2. That the Miami-Dade County Board of County Commissioners is urged to release the Town of Golden Beach, Aventura and Sunny Isles Beach from the County library system and assessment and to cooperate with these three municipalities in the transfer of library services from the Aventura Branch Library of the County to a local library operated by these three municipalities.

<u>Section 3.</u> Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

Section 4. Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

<u>Section 5.</u> Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.
