## **RESOLUTION NO. 1120.98**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA; APPROVING A MUTUAL AID AGREEMENT WITH THE CITY OF HALLANDALE, FLORIDA, FOR LAW ENFORCEMENT SERVICES; AUTHORIZING THE APPROPRIATE TOWN OFFICIALS TO EXECUTE THE AGREEMENT; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the continuing possibility exists that public safety concerns could cause the Chiefs of Police of Hallandale or Golden Beach to seek additional resources for law enforcement purposes on a short term basis;

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That the Mutual Aid Agreement between the Town of Golden Beach and the City of Hallandale, substantially in the form attached to and made a part of this Resolution as Exhibit A, is hereby approved.

Section 2. That in circumstances where said agreement and the Statewide Mutual Aid Agreement for Catastrophic Disaster Response and Recovery, dated April 24, 1994 and modified October 21, 1994 (to which the Town is a party) is also implemented, then the Statewide Agreement shall take precedence over this agreement with the City of Hallandale.

Section 3. That the Mayor and other Town officials are hereby authorized and directed to execute this agreement.

Section 4. Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the CR98065

remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

<u>Section 5.</u> Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

<u>Section 6.</u> Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.
