

RESOLUTION NO. 569-89

RESOLUTION AUTHORIZING CHANGE ORDER TO CONTRACT WITH MC COURT CONSTRUCTION, INC. IN THE AMOUNT OF \$13,543.45 FOR INSTALLATION OF LIGHT POLES AND FIXTURES FOR TENNIS COURTS.

WHEREAS, the Town of Golden Beach has contracted with Mc Court Construction, Inc. for the construction of two tennis courts and other work pursuant to plans and specifications as publicly advertised for bid; and

WHEREAS, the Town wishes to amend the agreement to include Change Order No. 1, in the amount of \$13,543.45 for the installation of poles and fixtures to provide electrical hook-up as per Exhibit "A" attached; and

WHEREAS, the Town Building Official, acting as Project Manager and the Town Architect, have reviewed and evaluated this proposal and have recommended that it would be more cost effective to have this work done at this time; and

WHEREAS, the Town Building Official has investigated prices from independent electrical contractors and has determined that this quotation represents electrical contractors and has determined that this quotation represents the lowest responsive bid.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF GOLDEN BEACH:

Section 1. The contract with Mc Court Construction Inc. is hereby amended to include Change Order No. 1 in the amount of \$13,543.45.

Section 2. That the attached Exhibit "A" is hereby made part of this agreement.







- Six single davit arms
- One 180° davit arm
- Two 70° davit arms
