



Letter from the MAYOR

am happy to announce that in September, the Town Council and I approved an \$11,583,700 budget for 2020. I'd like to thank the Town Manager and all of the Department Directors for their hard work in helping to put this budget together. In addition to maintaining the high level of service we provide to our residents, this budget will enable us to finalize our canal maintenance

recreational facilities.

It is projected that we will complete the paving of the streets in the coming weeks.

We are making progress on the New Town Hall and our priority this year will be finalizing the documents so we can issue the Request for Proposals and select a responsible organization to design and build the elements outlined in the design criteria of the Civic Center Complex Master Plan

We are aware of the unusual amount of flooding throughout the Town. The term King Tide is used to identify the phenomenon that creates sunny-day flooding because of the position of the moon. King Tide is not a scientific term, nor is it used in a scientific context. According to the National Oceanic and Atmospheric Administration, the recent flooding we experienced was a foot higher than predicted. The Town is committed to addressing the issue and to reviewing our pump stations and our outfall flaps on all of the islands.

Town Hall to get a new home

The Town Administration has been working tirelessly to solidify a Civic Center Complex Master Plan that will offer functionality, durability and amenities meeting the needs and wants of our Residents. Town Manager Alexander Diaz spoke at the September 26th Town Council Meeting, reiterating the tenets of the new Town Hall that were set forth when the project was first announced.

- To pay for the project without raising taxes
- To keep the scale of the project appropriate to our community
- To assure a new amenity or amenities to Residents
- To repurpose the existing Town Hall building

Following a year and a half of designing the Town has begun to unveil preliminary visions of what may be in store. **The Town will request bids for the project as a "design build" construction**. Mr. Diaz explained that with a "design build" project "(the Town) sets forth the basic elements we want in terms of programming (and) use." The architects' duty is to propose a concept that meets all of those design criteria elements (For example: square footage requirements, considering how many staff members must be accommodated, method of construction, parking quantities, etc.). Additional criteria that will be considered include: Is the team insured and bondable? Do they have at least five years' experience in the field? What are the quality levels and abilities of their design team?

The responding teams will be required to submit designs including floor plans, site plans and costs. "Design build" construction projects limit the feedback that clients can give in shaping designs, but offers the cost benefits that the client (the Town) is not being responsible for often costly change-orders. Instead that responsibility being handled by the design team. The Town is also protected from having "corners cut," as the minimum specifics of the build-out are laid out prior to going into construction, and can be used to compare against what is delivered. Designers will provide indicative floor plans which they will be required to adhere to, meaning if there are cost overages, they cannot make other alterations to compensate (shrinking lobby spaces, removing bathrooms). As part of the "design build" process the team must honor those minimum specifications. The Town will consider some fixtures and finishes as part of this process, but those selections will address critical elements including compliance with ADA and OSHA regulations (decisions such as brand names or model numbers will not be part of these considerations). Some essential features stipulated as part of the design criteria include:

- Vehicular Access to AlA
- Traffic flow for the complex to enter through Terracina Avenue and exit onto AIA
- Positioning of the mass of the complex away from neighboring properties
- Keeping existing Tennis Courts (which will be maintained and protected during construction)
- Maintaining the historic façade of the existing Town Hall building
- A safe-room bunker for Police and Essential Staff to safely reside in during storms/emergency events

The Town Council will appoint a selection committee that will be tasked with ranking the respondents' packages, with a minimum of three packages necessary in order to move forward with the review process. Each respondent will be required to make an oral presentation to delineate their design. Residents will be allowed to attend these presentations, but feedback will not be allowed during these presentations.

Once the submissions have been ranked, the Mayor, Town Manager and Architectural Engineer Lissett Rovira-Topaclioglu will make a recommendation for the proposal they feel most fits the scope of the project. They will judge which proposal seems the most responsive to the design criteria set forth by the Town. The Town Council will be able to refine the design. Upon commencement of construction, the selected architect team must provide progress plans at the 30%, 60% and 90% phases of completion. Submissions for the 60% and 90% phases will show information regarding finishes and aesthetics.








Residents showed up to one last bite of Summer as our Food Truck program drove off into the sunset.

< Ocean Boulevard Mailboxes

As part of streamlining the look of the Town's most traveled thoroughfare, mailboxes on Ocean Boulevard will be transitioned to the style used throughout Town. The new boxes will be installed in the coming months.

New Roof Over Our Heads

Town Hall and the accompanying Annex Building recently received necessary repairs to their roofs. With discussions of the new Civic Center/Town Hall facilities underway, both the existing Town Hall and Annex Building will be repurposed to house amenities for Residents.

Clearing the Way

Miami-Dade County Environmental Resources Management has approved the Town's permits to perform dredging in the intracoastal waterways. Work is expected to be underway soon with completion occurring by end of year



V Does your property have ground saturation?

There can be multiple culprits for water entering and lingering on your property: issues with elevations, faulty seawalls, or other unknown sources. This water can cause damage to your home's foundation, landscaping and even create a perfect breeding ground for mosquitos.

Pooling water affects more than the home from which it originates. Water can travel from one property into neighboring properties and into the Town's public areas before making its way into our drainage system. That excess water can overburden our system and create additional flooding in streets and other common areas throughout Town.

The Town has begun issuing warnings to homes that have issues with pooling. If you have questions on how you can improve standing water issues on your property please contact the Building & Zoning Department at Town Hall.

Attention > Pet Owners:

Dogs in the dog park MUST be accompanied by their owner inside the enclosed area. Any owner of dogs left in the play area unaccompanied will be subject to citations and may be banned from using the facility in the future.





< Beach Renourishment:

In order to protect private designation of beach-front properties, Beach Renourishment is an owner responsibility. However, the Town will not charge permit fees for owners who are looking to replenish sand on their beach. Also, the Town will facilitate delivery of sand for those owners. The Town is looking to identify shoreline stabilization remedies and will update Residents with progress.



Road Work < Continues:

The Town's milling and paving project continues to progress. King Tides and wet weather have delayed portions of the project. Milling of Golden Beach Drive was completed in its entirety to guarantee our scheduled slot with the paving company, and not cause additional delays. Please be sure to continue driving mindfully as surfaces are uneven.

From AlA to "A-l-Yay": Ocean Boulevard gets a Facelift

Residents of Ocean Boulevard rejoice, the Town has set its sights on AIA for its latest beautification initiative. The Town hopes to get an early jump on spring cleaning by tidying up the right-of-way areas along the length of Ocean Boulevard. The improvements will be provided free of charge, with the Town providing plants and covering the costs of removal and planting services. The initiative will help give a more cohesive unified look to the AIA corridor utilizing Florida native plants and landscaping that thrives yet does not require intensive upkeep.

Guidance on the project has been provided by the Town's Landscape Architect Kathy O'Leary Richards of O'Leary Richards Design Associates, Inc. A study of the proposed upgrades to each property is available now. Town Continues to Address Water

Pump Station for Center Island

In hopes of alleviating flooding, the Town Council approved the design and engineering for the Center Island Pump Station. The plans have been sent off to the State for permitting. The pump will cycle water, pushing it out until tides recede. The pump will be constructed where the dock currently stands.

The Town has also requested financing from the State to offset costs for the project. Town Manager Alexander Diaz and the Town's Finance Director Maria Camacho will visit Tallahassee to negotiate funding details. Construction is expected to begin after the first of the year with completion of the project following soon after.

Tennis Anyone?

The Town is also tackling water issues in Tweddle Park. New drains have been installed between the tennis courts and the new area designated for the pickle ball courts. This will keep water from pooling and spoiling your game; dry tennis courts, what's not to "love" about that?

North Park sees Repairs

Work has been underway to repair force drains in North Park to help prevent soggy sod.




