RESOLUTION OF THE TOWN OF GOLDEN BEACH AUTHORIZING THE MAYOR TO AWARD THE BID AND CONTRACT FOR THE PURCHASE AND INSTALLATION OF AN IRRIGATION SYSTEM FOR THE RECREATION PARK PURSUANT TO ITEMS SPECIFIED IN THE PUBLICLY ADVERTISED INVITATION TO BID AND RESULTS OF FORMAL BID OPENING HELD AT GOLDEN BEACH TOWN HALL ON APRIL 3, 1990 AT 10:30 A.M.

WHEREAS, the Town of Golden Beach has been awarded a State Recreation Grant for park development, and

WHEREAS, the approved plan includes landscaping and plants for an irrigation system, and


