RESOLUTION OF THE TOWN OF GOLDEN BEACH AUTHORIZING THE MAYOR TO AWARD THE BID AND CONTRACT FOR THE PURCHASE AND INSTALLATION OF SOD AND TOP SOIL FOR THE RECREATION PARK PURSUANT TO ITEMS SPECIFIED IN THE PUBLICLY ADVERTISED INVITATION TO BID AND RESULTS OF FORMAL BID OPENING HELD AT GOLDEN BEACH TOWN HALL ON MAY 7, 1990 AT 3:00 P.M.
