# G. MAYOR'S REPORT

Spoke on the bond referendum election. 77% of the residents supported the bond, we all appreciate your confidence in us. For those that voted against the bond, if you have any questions or concerns I urge you to speak to the Town Manager or myself. Tonight we will approve a resolution for the issuance of \$7 million G.O Bond. We are very excited. The Town Administration did a great job on getting the vote out. I commend the town staff, you guys did a great job in informing the voters to vote. Last council meeting the Council did approve setting the rate for the assessment at \$80 monthly. Residents will see the monthly amount or annual total of \$960 on the 2023 tax bill to come in the mail. I urge you to call and follow up to sign up for Hotwire. Whether you are signed up or not signed up, every home is going to pay the \$960 yearly. This summer, the Town finalized a 3-year contract with our police officers with the Florida State Fraternal Order of Police. I congratulate the Town Manager for initiating and completing the contract as well as the Police Officers that are here and all the officers that are not here. You guys deserve it and believe me if we could give more we would give more. The Council and I, and the residents appreciate everything you guys do for us. Also congratulated Chief Herbello and his staff for achieving their accreditation. When he was going around speaking to residents about the bond referendum, so many residents spoke so highly about the police. The Town has started the security walls on the north side and south side of town. The Town has pretty much completed the budget. Hats off to Maria, the Finance Department and the Town Manager. Once again, keeping the millage rate at 8.4 mills. Everyone has seen it whether it be at the pump, food costs or salaries. Inflation is really killing us, but the Town Manager and his staff did a phenomenal job with this year's budget. The assessed values of the town has grown to over \$1.4-billion and we will hopefully see more growth within the next few years. Think that all of the capital improvements that we are doing throughout town is going to add tremendously to the value of the Town of Golden Beach. The economy could change tomorrow, but the good thing is that the Finance Department and the Town Manager have been doing 5 year budget forecasts of revenues and expenses. We feel very confident with the fund balance and reserve for the next 5 years, and with the tremendous growth in revenue and controlled expenses, that the Town is very secure. We are in the midst of hurricane season, I urge all residents to be proactive. Get your home ready. If you have any questions, you can call Town Hall.

#### H. COUNCIL COMMENTS Councilman Einstein

# Spoke on the police department, needs to be expressed that you are really appreciated. If you look at our budget, you guys are a significant part of it. It's important to us and you are important to us. This has become a Town of very elite people. Think that the Town Manager and the \Mayor are projecting some of the needs that some of these people want and almost demand from us. Sometimes I try to grasp it because it's hard sometimes, but I'm only one person. There's other people that are living on the beach and buying properties for \$68-million and that's significant and we've got to address what those needs and wants are and it appears that we are doing something right because everyone wants to come here. Congratulations on putting the budget together.

# Councilwoman Lusskin

Look how far we've come. Golden Beach is a different Town. Always been pro-police. Appreciates everything you do for us. When I drive into Golden Beach I feel safe and I

feel comfortable and you have truly become family. Appreciate everything you do. The town is totally amazingly clean. Spoke on the wall at Massini Avenue stating that she feels that her work here is finally done.

# I. TOWN MANAGER REPORT

Under tight restrictions from the state, allowing us only to administer a factual campaign, we were able to pass the GO bond. We had the largest day of turn out in any primary election for the Town at 76.99%. This summer we took delivery of the generator of that pump station. This summer we spent it vigorously negotiating with the FOP – the largest and most respectable contract of the city's history, finally bringing their wages up to par. Accepted over \$800,000 in grant funding. Although the \$1.2-million was vetoed by the Governor, we did deliver an additional \$800,000 in funding that the residents did not have to pay for. This year we also were able to work on the Civic Center. There was a 45-day delay. The Town chose to stop the project while we waited for the concrete for the roof. We will be switching our medical insurance providers if the Council approves it. This is a better insurance plan for our members. We still have over 112 families who have not subscribed to Hotwire. Promise to have a cctv project delivered to you. This summer for the first time ever we were able to have an Ocean Boulevard residents meeting. Chief Herbello and his command staff were able to have a very successful zoom meeting with the Ocean Blvd. residents. That is one project that the Mayor and I feel adamant about not rushing in order to get it done right. Making sure that we provide the best security net on our east side is just as important as our west side. The north and south walls are almost complete. Thank you to all of the town's staff who helped provide security there around the clock. 60% of all new revenue went to the CBA contract. Did see the community values grow to 1.4 billion dollars. With new revenues come new responsibilities. This will be our seventh time keeping our millage rate at a combined 8.4 mills. Thanked Lissette Perez, Maria Camacho and all of our town's staff for all of the work that they did. Thanked Chief Herbello and Assistant Town Manager Linda Epperson for all of the work in their departments. And finally thanked the Town's Public Works Department for all of their hard work.

**Town Manager** spoke stating that we did start again. Delayed the project because we are asking for an owner driven change order to make the building Class A building. Currently scheduled to be a Class C building. The project is on schedule, with the change order today we are adding another 60 days. We are very confident in that delivery schedule. The majority of our long-term lead items have already been delivered. Still waiting on elevators and windows – should be delivered by December.

As it relates to your wellness center and reimagined Tweddle Park, you have a commitment from this Administration that before we take any steps and move forward with the wellness center we will work on the reimagined Tweddle Park. As part of our process this summer in speaking with our residents we have learned and we feel that the wellness center project has now emerged as a different concept.

We are now looking to build a wellness center that is more like a community clubhouse. We do not intend to hire any consultants to do this, we plan to do this in-house with architects. We currently have a lot of maintenance projects that we are currently working on, we feel that we are qualified to manage these projects. We know what we like and we know what we want, so you will be very pleased with what you will see.

As part of your project with the GO bond there are other projects enumerated in the GO bond. We feel that these changes in the design will help achieve delivering all of the projects that were enumerated in the wellness center.

The motion passed.

**Town Manager** stated that a few years ago Officer Carrazana introduced the Town to the Berenguer Group who helped the Town get from a United Healthcare to where we are now. Although the Town is not moving forward with renewing with them, wanted to thank Augustin and Juan with the Berenguer Group for everything they provided the Town.

Unfortunately they didn't meet the litmus test and the Town is recommending to go with Sapoznik Insurance as our new agent of record for all of our insurance offerings. We also recommend we switch from AvMed to Florida Blue Cross and Blue Shield (Florida Blue). Renewal rates came in at an 11% increase during the current fiscal year. This plan is a 7% increase but a much richer plan. We plan to keep the TransAmerica co-pay gap insurance.

In addition to being more competitive with coverage, this covers all of your labs.

The best part of this plan and this is what lost our current broker the plan, the prescription drug tiers. Under the new plan, if your medicine is medically necessary it now falls under one of three tiers. This allows us to keep CVS and it expands the number of hospitals you can go to. That is why we feel that this is a richer plan.

All of the brokers have a commitment to help us through the transition. The other great thing about Florida Blue, even though it is a 7% increase, we will not pay the premiums for the second month of the coverage. Did not factor those savings in, but will get that number to the Council.

**Christine Nunzio**, **Sapoznik Insurance** stated that participants will not need referrals, but all procedures will need prior authorization.

**Town Manager** stated that on all out-of-state travel, if you have an emergency you go to the emergency room and it will be covered. But if you have a runny nose, you go to an urgent care center. We want to work on educating our members to use the benefits that we are paying for anyway.

**Councilmember Lusskin** asked if rescue is called can the patient choose the hospital that they are taken to.

Town Manager stated that ambulance services are covered.

Councilmember Einstein asked about the League of Cities.

Town Manager stated that they refused to quote us.

Vice Mayor Mendal asked if there were any issues with the staff with the change.

**Town Manager** stated that there are some employees who will have to get the POS plan because their doctors do not take the HMO plan. But the Town takes these situations on case by case and try to help with these unique situations when they arise.

**Town Manager** stated that there will be premium increases to our members. Some of those premium increases will be absorbed by the one month rate pass.

The motion passed.

Town Manager stated that he ensured that Town staff is adequately trained and equipped in order to ensure to be the best of any small city to provide for its residents. Also, to be as competitively paid compared to neighboring agencies. Understanding that Town's revenue source for our community is limited at 380 buildable lots and majority of revenue comes from the community. This agreement is the single largest agreement that we will provide to employees and consumes 60% of all new revenue at a value of \$419,000 in Year 1 and puts us in par with neighboring agencies. This would adjust police salaries from its base pay of \$43,000 to cap out over a 12 year period. It is not what the Union asked for, but we feel that we have met pretty close to what they were requesting. The biggest impact of this is the variance of salaries. They come to work for the Town and dedicate 20 years of service and then retire and are competitively paid in comparison to neighboring agencies. It also provides for adequate compensation for our sergeants. We have the highest of 3 years for pension. This contract allows us to get closer to that higher number and be more competitive. We have increased the premium pay for specialty units as it relates to off-duty rates and we wanted to stay competitive with other cities while not passing that cost to the residents. The rates have increased significantly for vendors but increased minimally for residents. It increases the pay for FTO officers when they have a trainee with them. It also provides for HRA matching dollars. It provides for new bulletproof vests, which are cooler for the officers to wear. This is the most aggressive contract we have been able to provide. Would like to

publicly thank some individuals from the police department including David Carrazana, Sergeant Soca and Sergeant Bautista. Asked David Carrazana to come and speak on behalf of the union.

**Officer Carrazana** thanked the Council for understanding the needs of the officers and spoke on their behalf. They do not complain and tell us what they need to get done for the Town. They go out of their way to help the residents as much as they can.

**Town Manager** stated that they were very aggressive in negotiating this contract and in understanding how this contract will be implemented. Would like to remind both the members and the employees that this contract is mutually beneficial. Designed to keep more officers on the streets with more engagement with the public and with residents. They will be adequately compensated with the best equipment and best training in South Florida. It was a pleasure to negotiate this contract. All of our officers take great pride in working in our community.

Town Clerk read a letter into the record from residents Michelle and Peter Manners.

**Mayor Singer** added that the Town wanted to be competitive with the police contract and this new contract will add longevity with our police department.
