Recommendation:

It is recommended that the Town Council adopt the attached Ordinance No. 603.22 as presented.

Background:

There have been no changes since first reading.

The Town maintains a retirement benefit plan for its employees, which is known as the Town of Golden Beach Employees' Pension Plan (the "Plan"), and which is codified in Chapter 24 of the Town's Code of Ordinances.

The Town Council voted unanimously at the April 19th, 2016 Regular Town Council Meeting, to allow the Town Manager to join the Town's Employee Pension Plan.

This Ordinance as presented states that the Town Manager Member shall be eligible for normal retirement upon the completion of 20 years of Credited Service. It further provides that the Town Manager Member may participate in the Town's DROP plan upon completion of 20 years of Credited Service irrespective of age.

Fiscal Impact:

Currently the Town is required to contribute 32.16% of payroll to the pension. The Town has budgeted for the 2022-2023 fiscal year 35% of payroll for the pension. If the Manager were to join the Pension the Town would be required to contribute 33.31% (an increase of 1.15%), well within the budgeted 35%.

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AMENDING CHAPTER 24, "PERSONNEL," ARTICLE II, "RETIREMENT," DIVISION 1 "GENERAL EMPLOYEES" BY AMENDING THE TOWN OF GOLDEN BEACH EMPLOYEES PENSION PLAN AT SECTION 24-31 "DEFINITIONS, AND SECTION 24-34 "OPTIONAL FORMS OF BENEFITS"; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town Council of the Town of Golden Beach, Florida ("Town Council") has established the Town of Golden Beach Employees' Pension Plan (the "Plan") for members of the Plan as defined in Section 24-31 of the Town's Code of Ordinances ("Members"); and

WHEREAS, consistent with the Town Council's negotiation with the Town Manager regarding amending his employment agreement, the normal retirement date will be changed to reflect retirement eligibility and DROP participation upon the completion of twenty (20) years of service, irrespective of age; and

WHEREAS, to codify the negotiated retirement provisions, it is necessary to adopt an ordinance amending the Plan as set forth in Chapter 24, Article II of the Town Manager's Code of Ordinances; and

WHEREAS, the Town Council finds that adopting this Ordinance is in the best interest of the Town of Golden Beach, Florida (the "Town").

NOW, THEREFORE, THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, HEREBY ORDAINS AS FOLLOWS:1

Section 1. Recitals Adopted. Each of the above recitals is hereby adopted and incorporated as if fully set forth in this Section.

Section 2. Code Amended. That Section 24-31 "Definitions" of Division 1 "General Employees" of Article II "Retirement" of the Town Code is hereby amended to read as follows:

Sec. 24-31. - Definitions.

As used herein, unless otherwise defined or required by the context, the following words and phrases shall have the meaning indicated:

Normal Retirement Date means for each Member the first day of the month coincident with or next following the attainment of his 65th birthday if a General Employee, or if a Police Officer age 55 with ten years of Credited Service or age 52 with 25 years of Credited Service. Provided that effective October 1, 2006 the Town Manager Member or Police Officer Members shall be eligible for normal retirement upon attainment of age 52 and completion of 20 years of Credited Service. Effective [INSERT SECOND READING], the Town Manager Member shall be eligible for normal retirement upon the completion of 20 years of Credited Service. A Member may retire on his Normal Retirement Date or on the first day of any month thereafter.

Section 3. Code Amended. That Section 24-34 "Optional forms of benefits" of Division 1 "General Employees" of Article II "Retirement" of the Town Code is hereby amended to read as follows:

(6) Option 6—Deferred Retirement Option Plan for Town Manager Member. The Town Manager Member may elect to participate in the Deferred Retirement Option Plan (DROP) on the same terms and conditions as the DROP Plan for Police Members, except that the Town Manager Member may participate upon completion of 20 years of Credited Service irrespective of age. The DROP Plan for the Town Manager Member shall become part of the Plan and shall be administered by the Board as established herein.

Section 4. Repealer. All ordinances or parts of ordinances, resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.

Section 5. Severability. The provisions of this Ordinance are declared to be severable and if any section, sentence, clause or phrase of this Ordinance shall for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, sentences, clauses, and phrases of this Ordinance but they shall remain in effect, it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

Section 6. Codification. That it is the intention of the Town Council, and hereby ordained, that the provisions of the Ordinance shall become and be made a part of the Code of the Town of Golden Beach; that the sections of this Ordinance may be renumbered and/or re-lettered to accomplish such intentions; and that the word, "Ordinance," shall be changed to "Section" or such other appropriate word.

<u>Section 7.</u> <u>Effective Date.</u> This Ordinance shall be effective immediately upon adoption on second reading.

G. MAYOR'S REPORT

Spoke on the Veteran's Day event and how well it turned out and commended Councilmember Lusskin for her hard work towards it.

Spoke on the Halloween event and how great that turned out. It was a huge success with a great turnout by residents. Commended Michael Glidden and his staff for their hard work in coordinating the event.

Spoke on the visit last month from President Biden and how exciting that was for the Town. We presented him with a key to the city and a globe. It was an honor to have him visit the town. Commended Chief Herbello and command staff for their excellent work.

Walked the new Civic Center with Town Manager and CIP Director Lissett Rovira to check on the progress. It's moving slower than expected, but the progress is looking good. Hopeful that by the end of the first quarter, the building is complete and we've moved into it.

There's been a rise in potential crime in Golden Beach. Met with Town Manager, Police Chief and command staff and they assured us that they are doing everything they can to fight crime and avoid issues. We have extra patrol patrolling and undercover police working the area. We are aggressively tackling that. Safety and Security is the top priority to the council and myself.

We have recently had tremendous high tides. The pumps have been working well. Commended Public Works and Town Administration for a great job in keeping the pumps going. Several seawalls in Town are not up to code. Urged everyone to take their seawalls seriously.

It's the holiday season. Urge everyone if you're going away to keep your keys out of your car and notify town hall if you're going to be gone for any length of time.

Wished everyone a happy thanksgiving.

H. COUNCIL COMMENTS

Vice Mayor Mendal

Reiterated the Mayor's comments and commended to Councilmember Lusskin on Veteran's day event and everyone who helped put that event together.

Councilmember Bernstein

Commended Councilwoman Lusskin on the Veteran's Day event and how well it turned out. Changing the location made the event more impactful this time around, than it has other years.

Halloween just gets better and better.

Security quickly become one of his most important issues. We have a unique opportunity with Hotwire in upgrading our bandwidth and Wi-Fi. Now is a great time to look at how to improve the security. We have a small enough Town that we can have a security system that can notify the Police Department even if it is a false alarm.

Got a lot of calls relating to traffic and why can't we open the North and South gates. The gates need to be constantly monitored which is not feasible. We tried opening the

South gate while doing the Sandblasting. If anyone has any questions to please contact the Town Manager on the issue.

Spoke on the flooding. This is the worst that flooding has been to the point where water is almost going over the seawalls. The Town has done an amazing job of flood prevention. We are miles above everyone else in how we managed to care for the flooding.

Councilmember Einstein

Congratulated Councilmember Lusskin as well on the Veteran's Day event.

Spoke on the mosquitos in the parks.

Reiterated Councilmember Bernstein's statement on the work the Town did in handling the flooding situation.

Councilmember Lusskin

Thanked Michael Glidden and Jisel for all of their work on Veteran's Day. Had a wonderful turnout.

Really concerned about security. One of the most important things to her that is essential to this town.

I. TOWN MANAGER REPORT

Spoke on the Town's thanksgiving employee luncheon.

Urged councilmembers to reach out to the Town's new representatives.

Spoke on the crime spree in the Town and bordering areas. Most of the crimes happening are being run by adult criminals, but conducted by minors. The State Attorney's office is reluctant towards prosecuting minors and is not allowing us to arrest them. Instead, the State is asking us to let these minors go if they have been detained because they are not prosecuting them. We have changed the dynamic of our police scene and added marked patrol cars in afternoons and evenings. We take crime and policing very seriously. When the Town receives a call, we will go and help the victim first before we go meet with you.

Thanked Michael Glidden and his staff for the beautiful Halloween Event that they put together.

Thanked Councilwoman Lusskin for the beautiful Veteran's Day event that she put together.

Mayor did authorize that we increase our maintenance of the pump station to monthly. We had some minor issues due to the salt water corroding the panels. Agreed with Einstein that we cleared our streets of flooding within minutes.

The Council did authorize we bring in a pump into South Island Drive.

We cannot wait for the paving of South Island Drive to be over, the base has deteriorated so much that we need to replace the base of the drive. We resealed North Island Drive and it came out beautiful.

We are becoming more aggressive with our seawall enforcement. We feel that we cannot be delayed in asking our new owners to address their seawall concerns.

Although we may have had some issues with compliance, Mrs. Shaheen recently passed away and extended his deepest sympathies and condolences to the entire Shaheen family.

In relation to the mosquitoes, we are seeing more and more standing water in the Tweddle Park area and will start alleviating that standing water in that area.

As you know the Mayor, Councilman Einstein and Councilman Bernstein are up for reelection. The town's elections are February 21st, if you do not qualify by January 6th you will be ineligible to run for office in Golden Beach. Wished everyone happy holidays. Reminded council that town hall will be closed the last week in December.

J. TOWN ATTORNEY REPORT

Reiterated what the Manager stated that they are working aggressively to address the abandoned construction sites issue as well as the issues with the seawall.

Town Manager stated that they are being asked by more and more developers to table the time and not run the clock on their development. We are not taking that position. If you do not develop by the deadline, you will be asked to resubmit your plans to comply with the town's updated codes.

Town Attorney stated that we have found that many of the property owners who would historically come and reissue their permits and get another 180 days. If there's no construction, their permits will lapse. If they don't continue with construction, they'll get a warning that ultimately their project could be taken down.

Town Manager asked if we could address Item P11 out of sequence as some of the members on zoom have flights they need to catch.

Civic Center Construction Update

Town Manager stated that there have been some minor setbacks from the Town's own inspectors because they want to confirm we have compliance. There have been some corrective action taken as it relates to the lightning rod system. We had to do some structural repairs to it. The canopy has been installed, the interior framing is done, the electrical work is done, and there is still a little bit of work to be done with the plumbing particularly on the third floor. Worst case scenario, we have one more council meeting in these chambers before we move to the new chambers.

We are approving some additional site work tonight with the contract. Do not have an updated construction calendar for you, but hope to have one for you after tomorrow's meeting.

Town Manager stated that hiring architects to do new design for new buildings can run up to 20% higher in additional costs. The number they came in at was so competitive it would make much more sense to avoid. We feel that having the same voice in the complex makes sense. The plan is that the building and the courts and the wellness center all tie in together to create one comprehensive language for the civic center complex. We feel that they'll be able to provide you with an array of selections. Anabella has been stellar. Between Annabella, Lissett Rovira and myself we can deliver a building you can accept.

Councilmember Einstein asked if the town negotiated with them with regard to the numbers that were given.

Town Manager stated that there wasn't much negotiation. There was an original number the town received from them and that number was as competitive as this number. Not in the business of nickel and diming firms that are willing to assist us. They have donated their services to us to get us through the bond referendum. They've come to all of the meetings. \$69,000 is almost a laughable number for a firm to design and provide us with construction-ready documents.

Town Manager spoke on the item. We did issue a full-blown RFP with specifications and requirements for furniture selection. The company that submitted a bid not only met the bid requirements, but also offered the State of Florida Contract. The contract is for \$171K, asking for additional cushion of \$20K. The motion passed.

Town Manager spoke on the item. Stating that the town asked three different companies to come in and provide proposals for security to the town. The Town currently has a contract with Hotwire for internet services and a CCTV takeover system. We've eliminated all the contracts and came in with just one proposal. This proposal provides cameras on Ocean Blvd, Ocean, Golden Beach Drive, all of our parkways, and on the Inter-Coastal. We are looking at an additional 70 locations and a minimum of 208 additional lenses.

The cameras have smart analytics.

With this proposal, we will become the only city with CCTV cameras that will cover every inch of the community.

What set hotwire apart was their ability to finance the project for the town over the next ten years.

The contract requires 24/7, 365 monitoring. It requires their monthly maintenance of our system. For the first five years, all of the cameras will be under warranty. Should a

camera fail during the first five years they will replace them. Should a camera fail in year 6, we will be responsible for the replacement of that camera.

They are responsible for providing all of the infrastructure and installation. The Town is responsible for giving them the access to the private properties location. Lissett Rovira and Lt. Diaz will be our staff representatives in getting those easements for those properties.

We will pay \$37 dollars, for a minimum of 360 homes, a month for the next ten years. Did set aside 220,000 in our budget for this program. Are fully prepared to take on this additional financial obligation. We have had some unfortunate incidents, we feel that this security system will provide the tools that we need to alert our residents, and to keep us informed of what's going on in Town. This system will provide for the eyes that we need everywhere in Town.

Town Manager stated that he was going to provide a perfect example of how this camera system works. The cameras will alert the guard with a light and an alarm about suspicious movement. It will not find a moving car and take notice of domestic abuse; it will note a parked car at a suspicious hour. It will notice if a car parks and someone walks out and follow whoever is walking. It will determine suspicious activity and we will pre-determine the alerts we want for those individual cameras. Whether it be time, activity, behavior, etc.

Councilmember Lusskin asks how will the cameras know what's appropriate and inappropriate.

Town Manager answered that we tell the cameras what is considered suspicious behavior.

Town Manager stated that we're adding more personnel to the guardhouse. Overnight it now has two people, not one.

Councilmember Bernstein stated that years ago Aventura Mall had a specialized person who's trained to look at these cameras rather than different officers.

Town Manager stated that that's old technology. With the new system all you need is to have someone who can control the system. All of our officers and guards are trained on this new system. We only have one guard during the day because both Lieutenants and the Chief are all monitoring the system in their offices. We need more staffing at night. We have one guard in the booth and the other guard patrolling. In total, our staff will include 8 guards at different points around the clock, not at once.

Mayor Singer asked how long is it going to take to implement and install these cameras.

Town Manager answered that it hasn't been negotiated it because of the time frame to acquire the cameras.

Town Manager asked Wayne and David from Hotwire what are we looking at for deployment and buildout.

Wayne answered it depends on the supply and demand, but it could take up to six to eight weeks based on these particular cameras and it would take between thirty to forty days to install.

Mayor Singer asked when will Golden Beach start paying for this.

Town Manager stated that they won't pay until the system goes up completely. If we have this up by the fourth quarter of 2023 I will consider that a great success. Based on our current experience with the CCTV Takeover with Hotwire currently, there have been some considerable delays. The Town has not secured the easement we need for camera deployment along the waterways.

Mayor Singer asked the Town Manager how would he rate Hotwire with the current system they have in place.

Town Manager stated that it would be inappropriate at this venue. Most of the delays that hotwire has seen has been a supply chain issue. There are some hiccups that we need to focus on.

Mayor Singer stated that they are about to sign a big contract with them and he has some concerns also.

Councilman Einstein stated that what's their downside, ever. If his cable goes down for a day they still get paid, but when do they ever give back? Have they made any deals or offers for the Town?

Town Manager stated that our contract does have penalty clauses for system disturbances and they met all of their contractual obligations when the town had an outage, but our contract does have penalty language in it just like the CCTV contract will.

Councilmember Einstein stated that when it comes to a technical thing, the company never comes out of pocket.

Town Manager stated that there are performance requirements that if they don't meet their will be penalties assessed. Those have not been negotiated yet.

Councilmember Einstein asked what the penalties were for the system now?

Town Manager stated that as it relates to our town hall they are on task. The CCTV takeover issues are out of Hotwires control and we knew the issues may arise which is why we didn't have any damages for those issues.

Town Manager stated that in what they have delivered for the CCTV takeover, in speaking with command staff and road patrol they are extremely excited with what they have seen. We are confident that they will deliver the full CCTV takeover.

Councilmember Einstein stated that if we're spending 159k on this security system, could we just hire two more police officers instead.

Town Manager stated that it wouldn't cover the cost of two police officers – just one with their new salary rates and it doesn't solve the issue of the community.

Councilmember Lusskin stated that if she had a preference she would love a set of eyes looking at all of these cameras.

Town Manager stated that the way this item is written, it allows himself, the attorney and mayor to come up with the most aggressive language, and the strictest penalties to ensure compliance in an operable system that we can serve our residents. The bulk of what we need to have in agreement, we are there. When it comes to penalties, we're not there yet. But think you should have confidence in him, the mayor and town attorney to negotiate an appropriate contract.

Mayor Singer stated that he will not sign off on the contract unless he feels 100% confident on the contract and Hotwires services.

David Cejas, Hotwire Communications stated that transitions are never easy and do appreciate the feedback they're getting. Goal it to make sure that there is a seamless transition, even if there are delays sometimes. We want to make sure that everything is implemented appropriately and to the highest standards.

Wayne Thompson stated that part of their culture is to deliver and appreciates the feedback they are receiving because it gives them the opportunity to improve. Golden beach is an important contract for us here at hotwire. Goal is to work together to make sure that we are receiving what we need.

Mr. Ruben Selema asked what is the actual field of vision. Second, what is going to be the protocol for when an alarm goes off, they get notified at the substation, if somebody gets dropped off and they're in that field of vision, what is going to be the protocol for the police officers to respond to that particular incident. What is going to happen?

Town Manager responded that our cameras can only train our cameras to go to the right of way. What will happen is the cameras will alert the guardhouse of activity. This will be for use more during the nighttime and overnight since that is when 90% of the crimes are occurring. We will have enough guards during the night to look at those activities. We will be relying on those cameras to inform us of those activities. Right now, we depend on our residents on Ocean Blvd to inform us of those incidents because we currently do not have any cameras there. It will take some learning, it will take some time to grow accustomed to it, and it will take some time to train our staff and to get the right personnel to operate these systems.

Councilmember Bernstein stated he was concerned about the human error for what if someone were to step away.

Town Manager stated that we currently have relief officers to provide staffing in the guardhouse when someone needs to go on a break. Our commitment is that on afternoons and overnights, there will be two guards in the booth. One monitoring the CCTV system. We are dependent on the system to letting us know that something's going on. It's impossible to have enough sets of eyes monitoring one hundred forty four locations.

Councilmember Bernstein stated that he understood that there is a programming, but that there should be someone dedicated to monitoring those systems and alerts.

Town Manager responded that we will have two guards in the guardhouse in the afternoons and overnight and if we need to implement having a second guard in the mornings and during the day, we will include those costs in the next budget proposal. We don't need it as much during the day because we have enough command staff monitoring the systems that can assist us.

Mayor Singer agrees with Councilman Bernstein that when the cameras get installed that we need to evaluate because I do think we need to have someone there to monitor the screens.

Attorney Helfman gave some insight on the system at Indian Creek. They have a perimeter security system, which views the perimeter of the entire island, but their system is intended for anyone who is approaching the island from the water.

Vice Mayor Mendal stated that he has faith in the Town Attorney, Town Manager, and Mayor to negotiate the contract to be aggressive to meet the concerns of completing the contract.

Mayor Singer stated that his concern isn't the cameras doing a good job or not, his concern is whether Hotwire can deliver what they say they can deliver.

Attorney Helfman mentioned that there's 2 aspects. One is the construction and installation component. Then there's the operational aspect including the maintenance, training, equipment, and level of performance. We need to address both issues as we prepare a contract.

Mayor Singer stated that when it comes to Hotwire, he's satisfied with the installation of the internet, but he has issues with the way we've been making progress of the new Town Hall and the takeover of the existing cameras in Town. The promises that have been made numerous times have not been fulfilled. I won't sign a contract until I'm one-hundred percent confident that they will perform. I'll find out about that in the next thirty to sixty days. We want to make sure that we put provisions in that contract to make sure that we're covered.
