**WHEREAS,** Miami Mind is a non-profit organization that partners with mental health foundations to raise awareness and support the global mental health community; and

**WHEREAS,** Miami Mind's Mission is to shine light on mental health and allow those individuals who are currently suffering from mental health struggles to feel comfortable to speak freely about their state of mind; and

**WHEREAS,** the inaugural event will include a Mindful Night on March 20<sup>th</sup>, 2022 and an exciting pro-am tennis tournament on March 21<sup>st</sup>, 2022, with 100% of proceeds going towards the Concussion Legacy Foundation, Your Mom Cares Foundation and Spread Joy; and

**WHEREAS,** the Town Council finds that a contribution in the amount of \$2,500.00 to the Miami Mind Open Event is in the best interest of the Town.
