<u>Section 3.</u> <u>Implementation.</u> The Town Mayor and Town Manager are hereby authorized to take any and all action reasonably necessary to implement the purpose and intent of this Resolution.

Recommendation:

It is recommended that the Town Council adopt the attached Resolution No. 2816.22 as presented.

Background:

Our roads and streets are being evaluated frequently for proper drainage and catch basin debris removal. As time passes, the settlement of the roadways and curbs vary by location. There has been areas retaining water along Golden Beach Drive not flowing to the catch basins. The modification to the slope of the valley gutters must be revised in order to allow the proper flow of storm water to our outfall system. Additional revisions to be made include (11) catch basin elevation changes to match the new slope, Sidewalks, D-Curbs, resetting of pavers, and Asphalt repairs.

Fiscal Impact:

The fiscal impact for this project is \$43,579.00. Funds will come from the 541-465-000-000 Street Repair and Maintenance.
