#### **RESOLUTION NO. 2842.22**

A RESOLUTION OF THE TOWN OF GOLDEN BEACH, FLORIDA, AUTHORIZING AND APPROVING A CONTRACT WITH MOBILE SANDDUST BLASTING SOFL FOR SAND BLASTING ON OCEAN BOULEVARD; PROVIDING FOR WAIVER OF COMPETITIVE BIDDING; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town Council wishes to engage Mobile SandDust Blasting SoFI ("Mobile SandDust") to perform certain roadway improvements on Ocean Boulevard, which improvements consist of cleaning all of the curbs and gutters on Ocean Boulevard using a sandblasting method (the "Work"), for an amount not to exceed \$187,500.00; and

WHEREAS, Mobile SandDust has agreed to perform the Work; and

WHEREAS, the Town and Mobile SandDust wish to enter into a contract for the Work, pursuant to the terms of the proposal attached hereto as Exhibit "A" to this Resolution (the "Proposal"); and

WHEREAS, the Town did perform it's due diligence, receiving multiple proposals attached hereto as Exhibit "A" to perform the Work;

WHEREAS, the Town Council finds that compliance with the bid procedures set forth in the Town's Code of Ordinances ("Code") is impractical and not in the best interest of the Town; and

WHEREAS, the Town Council has determined that it is in the best interests of the Town to make the roadway improvements, and to approve a contract with Mobile SandDest; NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals Adopted.</u> Each of the above stated recitals are hereby adopted, confirmed and incorporated herein.

<u>Section 2.</u> <u>Authorization and Approval.</u> The Town Council hereby authorizes and approves a contract with Mobile SandDust pursuant to the terms of the Proposal attached hereto as Exhibit "A," authorizes the Mayor to execute the contract on behalf of the Town once approved as to form and legal sufficiency by the Town Attorney, and authorizes the expenditure of funds as detailed in the attached Proposal.

<u>Section 3.</u> <u>Waiver of Competitive Bidding</u>. Pursuant to the Town's Ordinance No. 540.09, the Town Council hereby finds that it is impractical to competitively bid the Work and not in the best interests of the Town.

<u>Section 4.</u> <u>Implementation.</u> The Town Mayor and Town Manager are hereby authorized to take any and all action necessary to implement this Resolution in accordance with its terms and conditions.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall be effective immediately upon adoption.
