A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AUTHORIZING THE PURCHASE OF POLES FOR THE TOWN-WIDE SECURITY CAMERA UPGRADE FOR AN AMOUNT NOT TO EXCEED \$120,000.00; FINDING THAT THE PURCHASE IS EXEMPT FROM COMPETITIVE BIDDING PURSUANT TO SECTION 2-275 OF THE TOWN CODE; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town desires to purchase specific types of poles for the Town-wide security system upgrade; and

WHEREAS, the cost to the Town to purchase the poles will not exceed a total of \$120,000.00; and

WHEREAS, the Town has engaged various vendors to provide competitive pricing for the purchase of the poles as found in the various proposals attached hereto; and

WHEREAS, pursuant to Section 2-275 of the Town's Code of Ordinances (the "Town Code"), the Town Council finds compliance with the bid procedures set forth in the Town Code of Ordinances is impractical and it is in the best interest of the Town to waive the bid procedure; and

WHEREAS, the Town Council hereby waives requirements of the Town's competitive bidding procedures; and

WHEREAS, in accordance with the Town's purchasing procedures, the Town Council authorizes the Town Manager and Mayor to procure poles from a vendor whose prices are consistent to those indicated in the various attachments to this Resolution for a total amount not to exceed \$120,000.00; and

WHEREAS, the Town Council finds that it is in the best interest of the Town to proceed as indicated in this Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. Recitals Adopted. That each of the above-stated recitals is hereby adopted and confirmed.

Section 2. Purchase Authorized. The expenditure of funds in an amount not to exceed \$120,000.00 for the purchase of poles hereby authorized and approved.

<u>Section 3.</u> <u>Implementation.</u> That the Mayor and Town Manager are authorized to take any and all action which is necessary to implement this Resolution, and the Mayor is authorized to execute a purchase agreement or proposal in connection with the purchase of poles for the Town-Wide Security Camera Upgrade, subject to the approval of the Town Attorney as to form and legal sufficiency.

<u>Section 4.</u> <u>Effective Date.</u> That this Resolution shall be effective immediately upon adoption.

the Town-Wide security camera upgrade

Recommendation:

It is recommended that the Town Council adopt the attached Resolution No. 2880.23 as presented.

Background:

The Town has been working with Hotwire over the past 10 months to design and specify the installation of the Town-Wide Security System. There are several parts to the project that the Town is responsible for that need to happen simultaneously in order to keep the project on track. Most importantly, in terms of lead-times, is the procurement of the poles.

The project requires two (2) types of poles: Type (A) poles will be used for all locations not adjacent to waterways; and Type (B) poles will be used in locations along the Intercoastal and Ocean.

Although the Town is responsible for procuring all poles, Hotwire is only responsible for the installation of Type B poles. The installation of Type B poles, calls for the use of helical pilings to stabilize the pole in the sand and near the seawalls.

Current market conditions estimates 18-24 weeks for the aluminum poles to be manufactured and delivered. During that time, the Town will be working on the infrastructure portion of the project. We must provide power to all locations and water to locations on the ocean, bridges and intracoastal (see attached Exhibit).

RE: Purchase of Poles for Town-wide Security Camera Upgrade

The Town has been working with several vendors to find the most competitive solution.

The Town is responsible for purchasing all poles for the seventy-eight (78) locations, and responsible for the installation of interior Town poles.

We are asking the Town Council to authorize a budget for the purchasing of all poles, granting the Town Manager and Mayor authority to make final vendor(s) selection.

As you will find in the supporting documents we are exploring pole options that range between \$900 to \$1,300 for Type A poles, and \$1,800 to \$2,100 for Type B poles.

The Town will order approximately

48 Type A Poles An amount not to exceed \$60,000.00 30 Type B Poles An amount not to exceed \$45,000.00

Contingency An amount not to exceed \$15,000.00

Total = **78 pole locations** A Budgeted amount not to exceed \$120,000.00

Fiscal Impact:

The cost for the purchase of the poles is \$120,000.00. These funds were budgeted in Fund 120-521316 where \$216,000.00 was budgeted for this project.
