GRAPHIC DESIGN Islander Media Group / AJ Fiegler As the summer begins to wind down, I'd like to welcome back the Residents of Golden Beach who may be returning from travels. I'd also like to give everyone an update on some of things happening here in Town.

#### **Keeping You Safe:**

To protect our Residents, their homes and vehicles from potential crime, the Golden Beach Police Department has taken robust crime-prevention initiatives. On top of the Department's daily protective duties, the GBPD has just added an additional Full-Time Officer and also a Part-Time Officer to patrol assignments.

As an added measure, the GBPD is working to hire two additional Public Service Aides (PSAs) for the Substation, so as to have in two PSAs working simultaneously at the Gatehouse afterhours. This added coverage will enhance the Department's ability to concurrently monitor CCTV cameras and visitor's vehicles coming into town.

In order to safeguard the ocean side of Town, the Beach Patrol rounds have been increased from (2) two ride assignments per shift to (3) three, and to improve police services while patrolling the beachside, a new Utility Task Vehicle (UTV) will be purchased as well.

Currently in order to boost staffing, the GBPD has all detached personnel on dual assignments, working at their respective Task Force Units and also working inside Golden Beach performing nighttime road patrol assignments once a week.

The Department is also engaging the community in various ways including the upcoming Soccer Game Day on Saturday, August 26 at 9:00AM. For details on how to join, please contact Officer Daniel Larrea at DLarrea@goldenbeach.us.

We encourage our Residents to join in on our community activities and hope that you'll be able to attend!

#### Budget Message:

To my fellow Residents of Golden Beach:

In the next coming weeks we will be presenting the 2023-2024 Annual Town Budget. Residents are invited to attend our budget



hearings, which will be held on **September 12, 2023** and **September 26, 2023**, both hearings will begin at **6PM** and will be held in the **Council Chambers at Town Hall**. I am supporting the Town Manager's recommended Budget, which calls for a combined 8.4 mills for the ninth consecutive year, due in large part to the unprecedented growth of the Town's property values, which now stands at \$1.6 billion.

With the growth in our assessed values, the Town continues to make significant investments in infrastructure and capital improvement projects. Each year, we work diligently to maintain the Town of Golden Beach in a manner that we can all be proud of and offer a variety of amenities for you to take part in.

This year we are committed to increase our security efforts by increasing our police presence, and delivering on the expansion of our Town-wide CCTV camera system. The camera system will provide coverage from the Intercoastal Waterways to our oceanfront homes, and all public areas throughout the Town.



### **Beat the Heat: Summer Safety Tips**

Summer is still here and the temperatures are high!

Keep these tips in mind to safely ride out the steamiest time of year.

- Stay hydrated. Drink plenty of fluids, even if you do not feel thirsty.
- Wear loose-fitting, lightweight, light-colored clothing.
- Slow down, stay indoors and avoid strenuous exercise during the hottest part of the day.
- Take frequent breaks if you must work outdoors, and use a buddy system when working in excessive heat.
- · Wear sunscreen and reapply as necessary, especially when swimming or sweating.
- Never leave children or pets alone in enclosed vehicles, even for a quick stop.

### **Littering - It's Your Beach**

Be considerate when using the beach, it is one of our most important natural resources in Golden Beach.

Whether it's the community beach area at the Pavilion or the sand behind your home, be sure keep things clean.

Food containers, party supplies (like those 4th of July fireworks canisters), even cigarette butts can migrate and make their way into the water or blow into neighboring properties. Plastics can pose serious risks when ingested by sea turtles and other sea life.

We can still celebrate while being a good neighbor and a friend to the environment. Pick up after the party is over.

"Leave nothing on the beach but footprints."

### **Film Permits**

Per Section 15 of the Town's Code of Ordinances, film permits are required for any commercial photography, still or motion (including digital content).

Commercial photography includes any works being published, uploaded, broadcast or utilized in **ANY way other than for personal** use.

Commercial photography ALSO refers to any shoots where a **professional photographer is hired**.

Film/Photography content for social media platforms, where content can be **commercially sponsored**, **uploaded or broadcast**, would constitute as a requiring a permit. These platforms include (but are not limited to) YouTube, TikTok, Instagram, Twitter, Facebook and similar content-sharing outlets.

Please note, film permits are NOT available for shared public spaces, including playgrounds, parks, streets, sidewalks, recreational facilities or any real property owned or controlled by the Town.

# Keep in mind, as part of Film Permit Applications:

- Film shoots are subject to fees. Fees are based on the number of persons who will be present at the time of the filming. This includes cast, crew, homeowners, and all other persons present.
- Neighbors living in close proximity to the location of the film shoot must be notified by mail.
- You must hire an off-duty police officer.
- If a tent is used, a temporary structure permit must be obtained from the Building & Zoning Department.
- Permit applications must be received a minimum of 7 days prior to the event.

# **Tennis Project Update**

Earlier this summer, the Town broke ground on our tennis courts construction site. The project is one of the first phases of the complete redevelopment of the Tweddle Park amenities. This ambitious project includes a complete reimaging of the site, along with elevating the ground level to assist with drainage.

The project is expected to run through the end of the year, demolition is already well underway, with earthwork and irrigation following soon after. We ask for your patience now as we continue to develop a recreational area that will last us for many years to come!

While the Tennis Courts may be closed, please note that other amenities in Tweddle Park remain open for the time being, including the playground and picnic pavilion area.



### **Enroll Now: BuildingLink**

A new way to get connected and stay connected is coming to Town. Golden Beach is excited to rollout BuildingLink software. BuildingLink will allow us to "build links" within our community in new and innovative ways.

The software will accommodate all sorts of tasks, from making tennis reservations, to applying for an event permit, to even scheduling secure deliveries of packages.

There are also message board capabilities allowing Residents to communicate with each other and Town staff in a simple and user-friendly way.

Please note, the platform will also manage the key-fob access to secured amenity areas of Town, if you would like to use secured amenities, you will need to register for a BuildingLink account. Secured amenity areas include the new Tennis Courts and Wellness Center.

Please also note: BuildingLink is an INDIVIDUAL-BASED USER ACCOUNT format (not family or household-based), so anyone wishing to have a key fob must have an INDIVIDUAL USER ACCOUNT registered. For example, if 3 people live in your household, and they would all like to have the ability to use Town amenities, they would each need to register a BuildingLink profile. There is no charge or fees to register for a BuildingLink profile.

We are beginning enrollment now, and expecting the platform to go live in the coming months. Enroll using the form attached, or visit www.goldenbeach.us to fill out the form electronically.

# **Iguanas: Unwelcomed Visitors**

Iguanas have become a common sight in South Florida, they can be seen sunning on seawalls or scuttling across lawns. These animals are non-native to Florida and are considered an invasive species. Iguanas can damage landscape plants and gardens, leave droppings in yards and pools, and cause damage to property by digging holes and burrows. Needless to say, they can be an unwelcomed visitor. So what can be done?

#### **Consider using some of these Deterrent Methods**

- Iguanas follow food sources, keep them away by limiting food options
  - o Iguanas will eat leftover pet food. Feed pets indoors or clear uneaten food right away.
  - o If you dine alfresco, be sure to thoroughly clean up food areas afterwards.
  - o Avoid planting plants that iguanas eat. Iguanas love to eat what we eat. Fruits like mangos and melons, and garden vegetables are favorites of iguanas. But they also eat Hibiscus, Orchids, and Roses. Some plants that iguanas do not eat include: crotons, citrus plants, and plants with thick, tough or waxy leaves that are difficult for the iguana to digest.
- Iguanas don't like to be bothered
  - o Do you remember those days of tanning by the pool and your little brother decided to spray you with a hose? It's not fun. The same goes for

iguanas. If you see them sunning on your property, give them a bit of a spray with cold water from your garden hose. Before long they'll get the hint and find someplace else to hang out.

o Too busy to keep an eye out for sunning iguanas?

Consider installing a "water scarecrow" or a

motion-sensor sprinkler to monitor areas that
iguanas frequent. When an iguana enters the area
it will receive an unwelcomed wetting and will steer
clear.

Keep in mind, as with all wildlife, iguanas are protected by anti-cruelty laws, and inhumane treatment of them is punishable by law.

The FWC recommends hiring a nuisance wildlife trapper for interested property owners who may find it difficult to perform trapping or human euthanasia on their own. A list of trappers can be found at MyFWC.com by typing "trappers by county" in the search box and clicking on the search result that says "Nuisance Wildlife Trappers"

## **Wildlife Tips**

• Don't Attract Wildlife to Your Home:

Animals are often attracted by food.

Keep wildlife away by keeping pet food indoors and be sure to clean up thoroughly after dining outdoors.

 For Issues with RACCOONS, POSSUMS, SNAKES, FROGS AND MORE....

The Town currently does not have services to address wildlife concerns on private properties and recommends Residents contact their own

### **Do Your Part to Keep Mosquitos Away**

#### **DRAIN**

- Drain standing water to stop mosquitoes from multiplying.
- Drain water from garbage cans, house gutters, buckets, pool covers, coolers, toys, flowerpots, or any other containers where sprinkler or rainwater has collected. Even tiny vessels like discarded water bottle caps can be breeding grounds for mosquitos!
- Discard old tires, drums, bottles, cans, pots and pans, broken appliances, and other items that aren't being used.
- Empty and clean birdbaths and pet's water bowls at least once or twice a week.
- Flush water collecting plants like bromeliads at least once or twice a week.
- Protect boats and vehicles from rain with tarps that don't accumulate water.
- Maintain swimming pools in good condition and appropriately chlorinated. Empty plastic swimming pools when not in use.

#### **COVER**

- Cover skin with clothing or repellent. Light-colored clothes have been shown to deter mosquitos, while mosquitos have been shown to be attracted to shades of blue.
- Consider Scent Choices Mosquitos can be attracted to fragrances like perfumes, colognes, and even scented body washes and deodorants.

   Always read label usage before you are not seen to be attracted to fragrances like perfumes, colognes, and even scented body washes and deodorants.

- Clothing Wear shoes, socks, and long pants and long-sleeves. This type of protection may be necessary for people who must work in areas where mosquitoes are present.
- Repellent Apply mosquito repellent to bare skin and clothing.
- Always use repellents according to the label.
   Repellents with DEET, picaridin, oil of lemon eucalyptus, para-menthane-diol, and IR3535 are effective.
- Use mosquito netting to protect children younger than 2 months old.
- Cover doors and windows with screens to keep mosquitoes out of your house.
- Repair broken screening on windows, doors, porches, and patios.
- Consider Gatherings Mosquitos are attracted to Carbon Dioxide (CO2); simply exhaling lets mosquitos know that there is a potential meal nearby. So the larger the gathering, the more likely mosquitos will join. So if gathering outdoors, use fans to disperse CO2, or gather indoors to avoid bites altogether.

**Did you Know?** You can call **311** to report mosquitoes or request a mosquito inspection

#### **Tips on Repellent Use**

 Always read label directions carefully for the approved usage before you apply a repellent. Some repellents are not suitable for children.

Products with concentrations of up to 30 percent DEET (N, N-diethyl-m-toluamide) are generally recommended. Other U.S. Environmental Protection Agency-approved repellents contain picaridin, oil of lemon eucalyptus, para-menthanediol, IR3535, or 2-undecanone. These products are generally

available at local pharmacies.

Look for active ingredients to be listed on the product label.

- Apply insect repellent to exposed skin, or onto clothing, but not under clothing.
- In protecting children, read label instructions to be sure the repellent is age-appropriate. According to the Centers for Disease Control and Prevention (CDC), mosquito repellents containing oil of lemon eucalyptus and para-menthane-diol should not be used on children under the age of three years. DEET is not recommended on children younger than two months old.
- Avoid applying repellents to the hands of children.
   Adults should apply repellent first to their own hands and then transfer it to the child's skin and clothing.
- If additional protection is necessary, apply a permethrin repellent directly to your clothing. Again, always follow the manufacturer's directions.

#### **Advisory: Mosquito Spraying**

Residents should plan for mosquito treatments to occur every Wednesday, before sunrise. Depending on need, the Town may not treat every Wednesday, but Residents should expect the possibility of spraying during that time period and plan accordingly.

Please make it a point to stay inside and bring pets indoors during spraying hours.

#### Feeling extra "bugged" by Mosquitos?

The Town will provide mosquito dunk tablets to Residents upon request. These can be used in areas of pooling or standing water. If you are interested in mosquito tablets please contact Town Hall at (305) 932-0744.

In addition to our Town-wide spraying, if you need mosquito treatment on your personal property, the Town is facilitating treatment service for Residents. The fee for each visit will be billed directly to the Resident requesting services by the mosquito treatment company; the Town is not responsible for individual spraying costs. To arrange a treatment, please call Town Hall and we will have the mosquito company call you directly to schedule.

# CODE NEWS

### **Parking Rules & Regulations**

#### Parking in Town, what to keep in mind:

- Follow State & Local Laws: The Town enforces regulations set up by the State of Florida, allowing vehicles to park legally within 20 feet of the end of a curb, from a stop sign or crosswalk, unless signage stating otherwise is posted, and as long as parked vehicles are not obstructing traffic. Vehicles not abiding by these rules are already subject to parking citation violations under the laws of the State of Florida.
- Don't Be a Nuisance: Town enforces additional restrictions, subjecting vehicles to code violations if parked in a manner constituting a public nuisance. Along with vehicles that obstruct traffic flow, vehicles that damage Town property including landscaping and turf while parking are considered a public nuisance. Offending parties are responsible for reparations and are subject to citations. Types of events that could cause issues with parking overflow include:
  - Parties: a resident having a party with more guests than their home's driveway can accommodate should contact the gate house at the Strand to make arrangements and avoid possible parking violations.
  - House Staff/Guests: For workers, house staff, and guests, residents must allow these types of visitors to park in their driveways if space is available. Residents whose service vehicles and guests' vehicles are parked in the street instead of occupying otherwise empty driveways will be subject to citations. Town residents who do not properly utilize their driveways to accommodate vehicles are considered to be creating a nuisance by unnecessarily obstructing of traffic flow.
  - Parks are not Parking Lots: In order to allow for usage for all Residents, homeowners surrounding the Town parks must park in their own driveways. do not use parking bays at the park as personal parking spaces.

- Landscaping Trucks: Landscaping service vehicles are allowed to park in the streets, but only if parking is not available in the resident's driveway, and as long as the vehicles do not cause disruptions in traffic flow. Vehicles should be parked with the wheel bases no more than 6 inches away from the curb.
- Maintenance Workers: Some service workers like plumbers, electricians, pool cleaners and landscapers whose trucks need to be parked on site to facilitate work may park in the right-ofways, but it is important to note that residents can be held responsible for damage caused to curbs and gutters which may crack or break under the weight of heavy trucks. These types of service vehicles are NOT allowed to park in Town cul-de-sacs, streets or along park perimeters.
- Additional Parking Options: When necessary, parking along auxiliary roads offer additional parking opportunities, specifically side streets without curbs, including Palermo, Ravenna, Verona, Navona, Massini and Terracina Avenues. The perimeter around Singer Park has also been designated as parking. When parking in these areas drivers should employ the "two-wheel-on-two-wheel-off" method, meaning they should pull up onto the right-of-way on the side of the street they are choosing to park, so that both their front and back tires on that side are off the roadway with the wheels on the opposite side remaining on the roadway. This ensures ample room for emergency vehicles to access the narrower side streets. Afterhours (late night and on weekends) drivers are allowed to use parking bays at Town Hall and also may park along the approaches at the Town's bridges.

With the current regulations being enforced, the Town strives to create a parking solution that best meets the needs of all residents. We ask for your cooperation and understanding as we continue to work to make Golden Beach a fantastic place to be.

# **Emergency Air Conditioning Repair Permits**

Work performed within Town requires proper work permits, whether it be new construction or repairs, but we know losing your air conditioning can be an aggravating and uncomfortable experience. Even with emergency repairs we ask that you follow these simple requirements to make sure your repairs comply with the Town's safety standards and regulations.

#### When you need to make an emergency A/C repair:

• Call the Town Building & Permitting Department and explain your situation.

• The Building Department will contact the Chief Mechanical Inspector and request permission for the repairs to be granted.

- If the Chief Mechanical Inspector approves the work, residents have 24 hours to submit a permit to perform the job.
- Any work performed without the proper permitting in hand leaves the owner exposed to possible code violations for work without permits, resulting in fines.

Be sure to follow proper avenues while performing repairs on your home and Stay Cool!

- Lawn clippings can block drains and cause flooding to your home and neighboring properties. Be sure your landscapers remove and dispose of all landscape waste.

# Below are some updates on current projects underway in Town:

#### **Civic Center Complex:**

Work continues at the new Civic Center main building, including priming and painting. Audio/ Visual infrastructure is in place and corresponding equipment installation is scheduled to take place in mid-August. Additional action expected during the month of August includes installation of security systems, millwork, plumbing fixtures and sprinkler placement.

Upcoming tasks will include the installation of the gold screening at the front of the building, exterior railings and building signage.

The building is expected to receive

its Certificate of Occupancy in November.

#### **Hotwire Services:**

Wi-Fi poles are being installed in parks to provide internet capabilities throughout Town.

Sites for security cameras along intracoastal waterways are being determined.

#### **Tweddle Park Redesign:**

Final selections and pricing are being made on lighting, paving, court coloration, and furniture.

Demolition to existing tennis courts is complete.



Site grading, fill and drainage work underway.

Delivery is expected in the second quarter of 2024.

#### **Upcoming Projects:**

Milling and Resurfacing of South Parkway, North Parkway, North Island and Massini Avenue is expected to occur in October 2023.




