A LETTER FROM COUNCILMEMBER EINSTEIN

POLICE BEAT

The following letter was read at the October 24, 2023 Town Council Meeting

October 24, 2023



My fellow Residents of our Town of Golden Beach, Mayor and Councilmembers,

I am before you with the heaviest of hearts. I collectively share with you the pain of the barbaric atrocities inflicted on an innocent people I will and cannot not remain silent --- I stand before you today

as a second-generation Holocaust survivor, bearing witness to a history marred by unimaginable horror and unspeakable cruelty. My personal connection to this dark chapter in human history is both profound and painful. All four of my grandparents, 16 uncles and aunts – my entire extended family – were slaughtered by the Nazis, their lives extinguished simply because of their faith, their heritage, their identity.

My parents, however, were among the few who emerged from the depths of Auschwitz, survivors of an ordeal that defies description. Their journey through that hellish place was a testament to the resilience of the human spirit. They endured inhumane conditions, witnessed the depths of human cruelty, and yet somehow found the strength to endure, to hold onto hope, and to carry on.

As the child of survivors, I have not only inherited the pain of their experiences but also the profound duty to remember, to honor, and to ensure that the world never forgets the horrors of the Holocaust. We must tell the stories of those who perished, of the millions of innocent lives that were extinguished in the darkness of hatred. We must also tell the stories of resilience, of survival, and of the unwavering human spirit that refused to be broken.

The Holocaust is not just a chapter in a history book; it is a chilling reminder of the depths to which humanity can sink when hatred, bigotry, and intolerance are allowed to thrive. It is a stark warning of what can happen when we turn a blind eye to discrimination and prejudice, allowing them to fester and grow.

Today, as we gather to remember the past weeks unmentionable atrocities in Israel, the slaughtering of innocent children woman and men – I want to look to the future. It is our moral obligation to ensure that the world never again witnesses such atrocities. We must teach our children the lessons of tolerance, empathy, and respect for all people, regardless of their background, religion, or ethnicity. We must stand up against hate in all its forms, knowing that silence can too easily become complicity.

In a world where hatred still rears its ugly head, it is up to us to be vigilant, to protect the values of freedom, democracy, and human rights. We must ensure that the lessons of the Holocaust are not buried in the past but are carried forward into the future as a living testament to the power of resilience, compassion, and the indomitable human spirit.

As a second-generation Holocaust survivor, my family's history is a haunting reminder of the importance of remembrance and the responsibility we all share to ensure that such horrors are never repeated. I honor the memories of my loved ones by standing together against intolerance, hatred, and injustice, and by creating a world where the light of humanity forever banishes the shadows of hatred and cruelty.

Thank you for listening to me in this solemn remembrance, and let us pledge to work together to make "Never Again" -not just a slogan but a promise to future generations. Please do not remain silent.

HOW FAST THIS YEAR HAS GONE BY.

In reflecting back it has been a year with many blessings, but also despair including the tragic events in the Middle East and one of our Sergeants being shot while pursuing car thieves. Still, many other great things have transpired in Golden Beach, especially with all of the progress with different infrastructure projects being developed to make this community the envy of South Florida.

All things considered, as we enter the holidays we still have some concerns that must be addressed to minimize the chance for you to become a victim of a crime of opportunity. Our officers continue to notice that residents are still leaving their vehicles unlocked with the car/house keys inside the vehicles. They have also noticed that residents are leaving the garage doors as well as their front gates wide open.

We need our residents to understand that crime doesn't occur spontaneously, and may occur days after the property was being surveilled/observed by a suspect(s). Crime Pattern is a way of explaining why crimes are committed in certain areas. Crime is not random, it is either planned or opportunistic. Crime happens when the activity space of a victim intersects with the activity space of an offender. A person's daily activity and/or pattern such as the arrival time at home, work, school, shopping areas, entertainment areas, etc. The course or route a person takes to and from these locations are called personal paths.

There is a Crime Pattern Theory that claims that a crime involving an offender and a victim can only occur when the activity spaces of both cross paths. Therefore, a pattern of behavior and/or daily routine will help assailants determine your daily routine and schedule and plan when to commit a crime.

Rules to Crime Pattern

- 1. Criminals travel on a day-to-day basis making decisions based on the daily activities of their victims. When decisions to commit crime are made, this is called a "crime template."
- 2. Usually criminals do not function individually, they are almost always involved in some type of network such as family or friends.
- 3. The accumulation of newspapers and mail is a sign that no one is home. Stop the correspondence and newspaper while on vacation.

- 4. Do not leave windows or doors unlocked. Close garage doors when not in use.
- 5. You might be surprised that not all of the homes are burglarized by strangers. A report from the U.S Department of Justice revealed that 66% of burglaries are committed by someone who knows the victim. Be cautious of who you allow into your home.
- 6. Limit visibility of valuables and make it hard for an intruder to see them from the outside.
- 7. Light up your house at night. It's a deterrent and it helps police search for offenders.
- 8. Instruct your Alarm Company to call the Golden Beach Police Substation before calling you or calling the Miami Dade Police Department. We don't mind checking your house, even if it is a false alarm.
- 9. Be vigilant. If you see something suspicious call us immediately. We would rather check the complaint and assure that everything is ok than risk potential criminal activities occurring. "SEE SOMETHING SAY SOMETHING"
- 10. Document serial numbers of all electronics, watches, etc. and take pictures of valuables.
- 11. Request a "Residential Security Survey" from the Golden Beach Police Department, which provides a general assessment of the vulnerability of your residence. For information, call the Executive Assistant to the Chief, Patricia Bocio at (305) 936-2444.
- 12. One final safety tip is that as you head home or even to work, if you believe that you are being followed, consider the following:
- > Call and/or go to the nearest police station.
- > If you decide to call, stay with them on the line and if possible give the 911-dispatcher a description of the car and how many occupants, while advising your trajectory.
- > If you are heading back home to Golden Beach, you need to advise the Guard House so we can wait for you at your residence and at the same time stop the occupants and question their motives.

NOTICE

From the Golden Beach Police Department RE: Lost/Abandoned Property

If you have any property that is in the possession of the Golden Beach Police Department, (GBPD) Property and Evidence Section, and you have been cleared to pick it up, please make an appointment to pick up your property. You must bring the following items with you: A Golden Beach Police Department Case Number or Court Case Number; A Picture Identification (State Driver's License, State ID Card, Passport, or U.S. Armed Forces ID Card); An original Return of Property court order (if applicable); A Golden Beach Police Department issued Property Receipt.

Lt. Leila Perez is the Property and Evidence Custodian, and anyone who has legal claim to said property, may contact the Lieutenant at Leilaperez@goldenbeach. us or you may call her at 786-859-5346 to set up an appointment.

Also keep in mind that there is lost and found (abandoned) property items that are in the custody of our Property Room. If you have a photo or description of what you lost, it would be helpful to reunite you with your found property.



Pursuant to Section 705.103, Florida Statutes:

After 90 days, the Golden Beach Police Department may elect to destroy the property, retain the property for its government agency, donate the property to a charitable organization, sell the property, or surrender the property to the finder, if it remains unclaimed.
