In the event of non-compliance the Building Official shall be notified immediately so that appropriate action can be taken. Further, upon completion of the work under each Building Permit, I will submit the completed inspection log form and sealed Statement of Compliance to the Building Inspector, at time of final inspection and before making application for Certificate of Occupancy. The Statement of Compliance shall state that, to the best of your knowledge, belief and professional judgment that those portions of the projects outlined above meets with the intent of the Florida Building Code and is in substantial accordance with the approved plans.
