WHEREAS, the Town wishes to engage TopTurf to design and install a Bocce

Court in North Park and Two Putting Greens in South Park ("the Project") for an amount

not to exceed \$40,676.95; and

WHEREAS, the received proposals from following firms: Southwest Green,

TopTurf, Legacy and Q-Ban Turf; and

WHEREAS, TopTurf submitted the most responsive and qualified proposal for

the Project; and

WHEREAS, the Mayor and Town Manager are authorized to execute a contract

in an amount not to exceed \$40,676.95 for all services related to the Project as outlined

in the proposal attached hereto as Exhibit "A"; and

WHEREAS, the Work is exempt from competitive bidding under Florida law, and it is

otherwise impractical to competitively bid the Work; and

WHEREAS, the Town Council wishes to approve the Agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWM OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals Adopted</u>. Each of the above stated recitals are hereby adopted, confirmed and incorporated herein.

<u>Section 2.</u> <u>Authorization and Approval.</u> The Town Council hereby authorizes and approves a contract with TopTurf pursuant to the terms of the Proposal attached hereto as Exhibit "A," authorizes the Mayor to execute the contract on behalf of the Town once approved as to form and legal sufficiency by the Town Attorney and authorizes the expenditure of funds as detailed in the attached Proposal.

<u>Section 3.</u> <u>Waiver of Competitive Bidding</u>. Pursuant to the Town's Ordinance No. 540.09, the Town Council hereby finds that it is impractical to competitively bid the Work and not in the best interests of the Town.

<u>Section 4.</u> <u>Implementation.</u> The Town Mayor and Town Manager are hereby authorized to take any and all action necessary to implement this Resolution in accordance with its terms and conditions.

Section 5. Effective Date. This Resolution shall be effective immediately upon adoption.

Recommendation:

It is recommended that the Town Council adopt the attached Resolution No. 3018.25 as presented.

Background:

Over the last several years, the Town has heard from residents expressing a desire for expanded recreational amenities at both North Park and South Park. The amenities most frequently requested include bocce courts, putting greens, paddle courts, and basketball courts.

While paddle and basketball courts are being addressed through the Tweddle Park redevelopment project, the addition of a bocce court in North Park and two putting greens in South Park represents an opportunity to respond to resident feedback in a timely and meaningful way using existing infrastructure.

To advance this initiative, the Administration solicited proposals from four qualified vendors for the design, materials, and installation of these new amenities. After careful review of the submitted proposals—based on cost, experience, and product quality—we are recommending that the Town Council approve the selection of Top Turf as the preferred vendor.

Top Turf demonstrated:

- Competitive pricing compared to other proposers
- Proven experience with the installation of recreational surfaces
- The ability to complete the work within the desired timeframe

Project Scope

- One (1) Bocce Court in North Park
- Two (2) Putting Greens in South Park

Renderings and proposal documents from all four vendors are attached for your review. Also attached are sample photographs illustrating the quality and type of installation proposed.

The Administration respectfully recommends that the Town Council authorize the selection of Top Turf for the installation of the bocce court and putting greens and approve the use of savings from the Wayfinding System capital project to fund the total cost of the work.

Fiscal Impact:

An amount not to exceed \$40,676.95.00.

The cost of this project will be funded from the remaining balance in the Capital Projects Fund that was previously allocated for the Ocean Boulevard Wayfinding System. Due to project savings achieved in that effort, sufficient unspent funds are available to support this enhancement without impacting other capital priorities.

Scope of Work Description:

(North Park) Bocce Court: Southwest Greens (SWG) crew will professionally install synthetic grass, Olympic Sport Rec Turf, in the designated North Park bocce court area. Size of the turf bocce court is planned to be 8' x 60'. Crew will install a 5mm perforated cushion padding underneath the turf bocce surface, to provide a buffer between the turf surface and the drainage rock foundation, producing a smooth-rolling bocce experience. SWG crew will install an approx. 8"x8" ground contact pressure treated lumber border to frame the bocce court.
